Details: On 03-13-11 at approximately 1639 hours, Suspect Ventura forces his way into the home of Victim Steven Bodine and strikes Victim Bodine in the face causing superficial facial injuries. Suspect Ventura and two other unknown suspect's tie Victim Bodine up with speaker wire and proceed to tie clothing around Victim Bodines face limiting his view. Suspect Ventura and his associates ransack the residence, taking personal items belonging to Victim Bodine. Suspect Ventura who is known to Victim Bodine is taken into custody at the home of Suspect Ventura. No property was recovered and Suspect Ventura invoked following Miranda.

Suspect Ventura was booked and lodged at the Tulare County Main Jail on 212.5 PC and 3056 PC.
