Dale Simmons, Chair of the Environmental Committee talked about the upcoming Earth Day activities and invited the Council to participate. The El Diamante Green Club, which is helping to promote the day, presented a video about their recent activities.

Seyed Sadredin, Director of the San Joaquin Valley Air Pollution Control District provided a video presentation and handouts regarding Valley air quality and the need to take steps to improve air quality.

Track 3 4:30 p.m. 3. Presentation of the 2010 Visalia Convention and Visitors Bureau annual report.

Anil Chagan, Chair, Robert Lee, Vice Chair, Aaryn Skaggs, Sales and Marketing Director and Danika Heatherly, Convention and Visitors Bureau Manager gave a presentation on the CVB's 2010 accomplishments.

Track 4 4:50 p.m. 4. Update from Ted Smalley, TCAG, regarding short-haul rail issues in Tulare County. *No written materials*.

Ted Smalley, Executive Director of TCAG and Tom Sparks, Chair of the TCAG rail subcommittee, provided an update on TCAG's effort with rail, and plans for the future to ensure short haul rail is available for industrial purposes. Smalley clarified that Measure R is not involved in any rail proposals, and mentioned that there is a bill in the State Senate that would allow the creation of a Central California Rail Authority. If created, the Authority would operate as a JPA.

Dave Segal, Marketing and Sales Manager for San Joaquin Railroad also spoke and clarified that there is no risk to rail service in the industrial park. He said it is a profitable line; however, they don't know if they will have the resources to be able to upgrade the road from Exeter north to Fresno.

5. Review and comment on the Draft 2011/12 Action Plan for the use of U.S. Department of Housing and Urban Development (HUD) Community Development Block Grant (CDBG) and HOME Investment Partnership Funds administered by the City of Visalia's Housing and Economic Development Department; and 2<sup>nd</sup> Amendment to 2010-11 Action Plan and 3<sup>rd</sup> Amendment to the 2009/10 Action Plan.

Ricardo Noguera, Housing and Economic Development Director, and Rhonda Haynes, Housing Specialist, discussed the plans for the HUD, HOME and CDBG funding for the 2011/12 fiscal year with the assumption that there will be reductions in funding. They will continue with several programs including the Continuum of Care for the homeless, counseling services, the Foreclosure Acquisition Program and Oval Are Park Improvements.

The following items were removed from consent calendar for separate action: 9m (Lane); 9N (Nelsen).

- a) Authorization to read ordinances by title only.
- b) Introduction and first reading of Ordinance to remove local amendments regarding fire sprinklers in non-residential buildings and apply fire sprinkler standards contained in the 2010 or most recently adopted California Fire Code. **Ordinance 2011-06 required.**
- c) Second reading and adoption of Ordinance authorizing the contract amendment for miscellaneous personnel between the City of Visalia and the Board of Administration of the California Public Employees' Retirement System (CalPERS). **Ordinance 2011-02 required.**
- d) Second reading and adoption of Ordinance which clarifies the required number of calls for service (except medical emergencies) before a property can be inspected for violating the management quality standards described in Visalia Municipal Code Section 15.44.160C and 8.40.060C. **Ordinance 2011-03 required.**
- e) Second reading and adoption of Ordinance declaring Real Property Surplus and approval of the Purchase and Sale Agreement and Escrow Instructions for the city-owned real property located at 210 NW 2nd Avenue (APN: 094-031-009) to the Visalia Rescue Mission. **Ordinance**

- f) Second reading and adoption of Ordinance approving Change of Zone No. 2011-02: A request by the City of Visalia to change the Zoning designation from Service Commercial (CS) to Central Business District (CDT) on 12.47 acres of land. The project area generally extends along Santa Fe Street to Tipton Street, from Center Avenue to Race Avenue. Ordinance 2011-05 required.
- g) Authorize Jeffco Painting and Coating to perform the Primary Clarifier No. 4 Coating Project in the amount of \$382,840.
- h) Award contract for the purchase of one (1) Ford F-250 and two (2) Ford F-350 to Visalia Ford in the amount of \$132,906.78 for the Waste Water Treatment Plant.
- Authorize purchase of a new Fire Engine for \$496,315 and additional equipment for up to \$35,000 to be funded by the Measure T Expenditure plan.
- Authorize the City Manager to sole source contract to Aqua- Flo Supply in the amount of \$858,740 to install, upgrade or retrofit Toro Sentinel water management controllers in the Landscape and Lighting Districts and NE Districts and appropriate additional funds of \$322,440.
- k) Declare an Intention to Abandon Laurel Avenue between Shady Street and Woodland Street and set the date of public hearing for May 2, 2011. **Resolution 2011-13 required.**
- 1) Authorize the City Manager to enter into an amended contract in the amount of \$21,750 with the consulting firm of Dyett and Bhatia for professional services for the General Plan Update.
- m) Award a construction contract and authorize the City Manager to execute an agreement for RFB No. 10-11-46, Shirk and Ferguson Trench Settlement Repairs in the amount of \$483,430 to the low bidder Bill Nelson General Engineering Construction, Inc.

Council Member Lane asked questions regarding why there was only one bid and some of the restrictions within the bid that may have limited the number of respondents. Staff explained the requirements and limitations that were associated with the Federal funding source for this repair.

n) Authorization to enter into a contract with the Bureau of Reclamation to receive unstorable water from the Central Valley Project. Resolution 2011-14 required.

Council Member Nelsen asked staff to explain why they were recommending paying the delivery fees that are associated with this water that make this water more costly than some of the water the City has purchase in the past.

o) Authorization to join with the California Partnership for the San Joaquin Valley and Southern California Gas Company in opposing the proposed diversion of the Energy Efficiency Gas Surcharge Fund to the State General Fund.
