Details: On 8/22/11 at 0900 hours members of the Tulare County Sheriff's Department, Visalia Police Department Property Crimes Unit, and the auto theft task force (T-RATT) conducted a probation search at the 1200 block of W. Wren, in the City of Visalia. During the search the listed suspects were found to be in possession of several stolen items taken from numerous thefts and burglaries that occurred throughout the City and County. The suspects were linked to four separate residential and vehicle burglaries that occurred between 07/21/11 and 8/21/11 in Kingsburg, Kings County, and on south Mooney Blvd. in the City of Visalia. During the investigation and with the assistance of The Kings County Sheriff's Department, the suspects were linked to an additional burglary that occurred in a rural area in Kings County on 8/21/11. 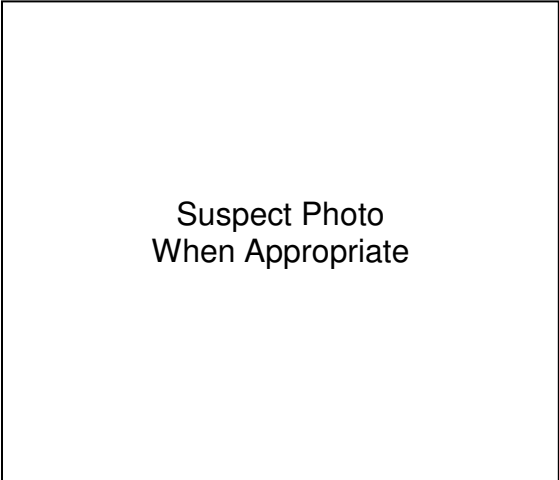
