Irene Lapin, W. Feemster, commented she is disappointed in the selection process and questioned procedures and qualifications for selecting the Task Force Members.

Council members discussed the outreach to the public that they did in order to solicit applicants. Council discussed that Mr. Salinas did not fill out all of the application and shouldn't be selected as that would not be fair to the applicants who completed the process correctly.

Council appointed Paul Chao and Maggie Florez (Salinas not appointed) to the Task Force and asked the Task Force to select the final member from the applications submitted.
