**Details:** On 10-8-11 at 0350 hours, Officers responded to a report of a fight in progress at Food Maxx on Ben Maddox. Officers encountered two groups in the parking lot with the Suspect driving a '01 Dodge Durango. The Suspect was attempting to flee the scene after colliding with a '01 Honda Civic and striking the listed Victims. Self and Torres were both struck as a result of the Suspect attempting to ram the Civic out of his way after a fight between the two groups of individuals. Approximately eight individuals were involved in the fight. Both Victims were transported to KDMC for minor to moderate injuries, no further information was available regarding their condition at time of press release. The Suspect was arrested and booked at TCJ for assault with a deadly weapon (vehicle) and also DUI with injuries, as he was found to be under the influence of alcohol. No injuries were reported as a result of the fight.


