## **CITY UPDATES**

Building Permits Show Bump in Commercial Projects, Residential Additions: The total value of all permits issued this year through November is up 18% - \$127,298,311 compared to \$107,904,187 for 2010. Single family dwelling permits continued their decline, down 31% from 279 in 2010 to 192 for 2011. In contrast, new commercial permits were up 45%, from 20 in 2010 to 29 in 2011,

and the value was up 177%, from \$13,968,175 in 2010 to \$38,627,950 in 2011.

Multi-Family Affordable Housing Development Completed: The Court and Paradise Apartments in Visalia will celebrate its grand opening at 2 p.m. Wednesday, Dec. 7, at 1526 S. Court St. The apartments are the result of the efforts of a partnership with Kaweah Management Company, the Tulare County Housing Authority, Visalians Interested in Affordable Housing, the City of Visalia and the Visalia Redevelopment Agency. The project is unique because Kaweah Management Company and the Tulare County Housing Authority were able to acquire an existing apartment complex immediately adjacent to an old home and vacant lot, renovate the 11 rental units, relocate the home and construct a total of nine new rental units on the vacant lot and parcel where the home once stood. The City and the Redevelopment Agency contributed \$1 million toward the construction and rehabilitation phases of the project, with \$500,000 in HOME funds and another \$500,000 loan in Redevelopment low-mod funds.

## **COUNCIL MEETING RECAPS**

Council Hears Update on Status of Downtown Infrastructure: The City's century-old downtown buildings and modern fire codes and regulations are not a match made in heaven. City staff members from Administration, Engineering and the Fire Department formed a committee five months ago with Downtown property owners/representatives Harvey May, Don Celillo, Stephen Peck, and Mike Fistolera. The group, including representatives from Southern California Edison and California Water Service, has focused on trying to find practical solutions to the cost-prohibitive issues that often prevent anyone from attempting to rehabilitate or expand downtown structures. The group has identified infrastructure issues (electrical service upgrades and fire protection systems) and developed a strategy to address each. The problem is how to finance the concepts. The City will discuss options and develop possible solutions with the Downtown Property Owners Association. For the complete staff report, click here.

RFP Process Begins for 911 Communications Center: The City Council received an update for the new 9-1-1 Communications Center/Public Safety Facility Project from the Core Project Committee. Council authorized the committee to proceed with the RFP process to hire an architectural/engineering and design consultant to plan, design and provide construction documents for the project. Phase 1 will include the evaluation and selection of a site for the 9-1-1 Communications Center, a facility needs assessment, preliminary design and estimate, and the development of an overall site plan to include essential and non-essential service facilities. The following timeline for the RFP process is anticipated: January / February 2012—Begin RFP Process (open bid 30 days); February / March 2012—Committee Review RFP's, invite consultants to Pre-Interview Conference, select consultant; April 2012—Update Council and recommend consultant for hire.
