The Visalia Police Department Command Staff is comprised of the Chief of Police, three Captains, six Lieutenants, one Support Services Manager, and one Financial Analyst. The Visalia Police Department consists of three Divisions: Administration Division, Operations Division, and the Operations Support Division. Each Division is led by a Captain and includes Bureaus and Units.

Visalia has a population of 129,582. The Visalia Police Department has 224 employees; 140 sworn, 68 full-time civilians, and 16 hourly employees. There is an additional 5 Reserve Officers.

### **Nextdoor Launched in 2014**

### Nextdoor is a virtual neighborhood.

Crime Prevention launched Nextdoor, a social media site for neighborhoods. This platform is incorporated into the Neighborhood Watch Program, adding a virtual component to stay in contact with both established Neighborhood Watch groups and individuals throughout Visalia. Crime Prevention will also share safety information, alert residents to community events the Visalia Police Department is participating in, and get the residents of Visalia engaged with the police.

Nextdoor users are reminded this platform is not a method to report emergencies, criminal activity, or request any other assistance from the Department. Existing reporting methods are used in such instances.

Currently, there are 29 launched neighborhoods and 16 pilot areas. There are 870 households using Nextdoor to communicate and share information with their neighbors.





# CAD / RMS Acquisition


The City of Visalia seeks to improve its public safety application software environment by replacing the Computer Aided Dispatch (CAD) application and the Police Records Management System (RMS). The current CAD / RMS solution was procured in 1984, last upgraded in 2007. Recently, the entire platform was changed.

The City hired Deltawrx, an independent consulting firm, to prepare a project master plan that examines the current communications, records management, report writing environments, identifies the general requirements of a new solution based on the Police and Fire Departments' business needs, and defines the optimal procurement scope, including an estimated timeframe and budget. The objective of the CAD / RMS replacement project is to smoothly transition to a state-of-the-art system that assists the Police and Fire Departments in keeping the public safe and provides employees the opportunity to perform at the highest level possible.

Core personnel and project teams have been identified and are active in the selection process. Functional requirements were identified by every unit in the Department. Pictured below is Robin Meyst, Project Manager. The Evaluation Team is shown at a CAD / RMS demonstration.











### **Police Officers Assigned to Middle Schools**

The Youth Services Unit of the Visalia Police Department was created approximately 37 years ago to provide guidance and police services to the students and staff of the Visalia Unified School District, as well as all youth of Visalia.

There are currently eight officers assigned to the

Unit, one to each of the high schools, one to each of the intermediate schools, and one officer assigned to the Police Activities League (PAL), which falls under the umbrella of YSO.

The Department received a grant from the U.S. Department of Justice, Office of Community Oriented Policing Services, to partially fund three new Youth Services Officers in the latter part of 2013.

The YSOs were selected and placed in the middle schools in January 2014.

Assigning officers to middle and high schools provide opportunities to be

proactive, identify problems, and develop solutions which have long-term results. Their presence is effective in providing positive role models, mentoring, and early intervention and prevention. These officers help to partner police, schools, staff, parents, and the community, furthering our commitment to the enrichment of our youth.

The City of Visalia has a long-standing history of collaboration with the Visalia Unified School District to provide police officers who serve at the schools.

YSOs participate in many activities. Some are: the Cowhide football game, the Battle for the Saddle, the Candy Cane Lane Parade, PAL coat giveaway, and breakfast with Santa.



Sergeant Jon Pree Volunteers in Police Service (VIPS)

The VIPS Volunteer of the Year is Dave Freitas. Dave joined the VIPS program in 2000. He has completed 1,215 hours of service. Of those, he completed 98.5 hours in 2014. He primarily serves at the Police Activities League facility repairing bicycles, which are given to local youth. Dave also serves at the Visalia Mall office to answer questions and assist citizens with their needs.

Murna Dicks volunteered more than 10,500 hours since she began working at the Department.

The Records Unit processes, distributes, and maintains over 15,000 reports per year. Employees attend mandated training to ensure they are complying with records release laws, along with Department of Justice and Department of Motor Vehicle regulations. A total of 23 employees are utilized to maintain operations at Headquarters, and at the District 1 and District 2 Substations. They provide services at each location, including: processing payments, vehicle releases, report requests, transcribing narratives and preparing arrest and in-custody packages for submission to the Tulare County District Attorney's Office.

**Crime Lab** - A complete Automated Fingerprint Identification System (AFIS) terminal was installed in the Crime Lab. This system allows staff to enter latent fingerprints into the CAL-ID system to check local, state and federal databases. During 2014, the Crime Lab received 145 cases with latent prints, 109 cases had prints of comparable quality. There were 14 case hits (80 individual hits).



**Crime Lab Fleet -** Replacing a Chevrolet Impala, a fully equipped Ford Expedition is used to process crime scenes. It features an Extendo Bed for easy access to equipment, a 1000 watt power inverter, Wi-Fi printer and a Streamlight LED crime scene light.


