Alvarez stated that the Department's Traffic Unit has been impacted by the large amount of Fatal Collisions city-wide; therefore, they have been unable to provide as much speeding enforcement as desired. However, the request will be made to the Traffic Unit and to former Traffic Officers who are now assigned to District 1 who are radar trained to attempt to conduct the necessary enforcement.
