- 5. CONSENT CALENDAR Consent Calendar items are considered routine and will be enacted by a single vote of the Council with no discussion. For a Consent Calendar item to be discussed, or voted upon individually, it must be removed at the request of the Council.
- a) Authorization to read ordinances by title only.
- b) Authorization to set October 6, 2003 for the first reading of **Ordinance No. 2003-16** an amendment to the City of Visalia Municipal Code Section 8.28.090 (Special Hauling) of the City Garbage Collection Ordinance.
- c) Authorization for the City Manager to execute a Joint Use Agreement between Southern California Edison Company and the City of Visalia for relocation of power poles on the south side of Goshen Avenue east of Ben Maddox Street.
