Vice Mayor Kirkpatrick notes to staff to continue to keep a close look on the management of this project. Public Works Director Andrew Benelli addresses the questions from Council.

Item 8 Track 10 GK/GC 4-1 (Landers-No) Approved 8. **PUBLIC HEARING** to consider reinstating the building permit fees to 85% of the pre-fee reduction rates. After hearing testimony, consider approval of proposed Building Permit Fee Schedule per **Resolution 2006- 92**.

Financial Manager Gus Aiello presented a PowerPoint briefing the Council on Building Permit Fees. Mayor Gamboa opens the Public Hearing; Bob Keenan from Building Industry Association wants staff to monitor the revenue closely, and is in support of this item. City Manager Steve Salomon comments on the cost of operation going up and states that the expenditures also need to be monitored. City Attorney Alex Peltzer also addresses Council's questions regarding fees.

Item 9 Track 11 DL/BL 5-0 Approved as amended 9. **CONTINUED PUBLIC HEARING** -Presentation and discussion of angled parking along the south side of Center Avenue between Bridge Street and Conyer Street and additional angled will also be added parking along various roadways in the downtown area. Authorize staff to seal the road way surface of Center Avenue between Bridge Street and Conyer Street and re-stripe Center Avenue for angled parking along the south side of Center Street. **Resolution No. 2006-94 required**.

GK/GC 4-1 (Link-No) Approved as amended Authorize to consider a change in our CIP for \$150,000 for bulb-outs Council questions regarding the timeline, bulb-outs, maintenance, speed limit, etc. was directed at city staff. Senior Civil Engineer Eric Bons and Public Works Director provided information regarding the design of the angled parking and bulb-outs. Councilmember Link request that this item be amended into 2 motions; 1 for the angled parking and the other for the bulb outs. Mayor Gamboa calls for two motions.
