Councilmember Landers commented that he was supportive of the committee's & staff's recommendation as presented. Associate Planner Brandon Smith provides a brief review of the item. Comments were made by Council. Mayor Link invites interested audience members to make brief comments related to this project. John Delew, Steven Peck, Bernard Tevelde, Robert Dowds, and Wimpy VanGrau spoke in support of the project. Continued discussions were made by Council, staff addressed comments & concerns. Motion by Councilmember Kirkpatrick staff recommendation with the amendment that staff returns to Council to present a process & resources to complete a comprehensive planning effort in this West Visalia Areas within one year; Seconded by Vice Mayor Gamboa; vote 3-2 (BL, WD, DL - No; JG, GK - Yes) Motion Failed. Motion by Councilmember Landers to Initiate the Annexation & General Plan Amendment & direct staff to converse with applicants to discuss relocation of the ponding basin to an appropriate location along 198 to act as a buffer, and provide a recommendation on what that area might be north of Cypress & proceed with appropriate GPA & land use changes for the area south of Cypress to accommodate the applicant's request for the Professional Office Skilled Nursing Facility in the residential Sierra Village expansion; Seconded by Councilmember Deissler. Continued discussion between Council. Motion approved. Councilmember Kirkpatrick presents his recommended motion for Council approval for a comprehensive plan; further discussion made. Motion withdrawn. Staff to return in June for further discussion as directed by the Council.
