Department Recommendation:

That the City of Visalia and the Visalia Unified School District continue to work on the feasibility of a joint venture to establish an aquatic facility at a future school and/or park site, and that staff be authorized to establish an ad hoc committee to bring back alternatives and ideas for a new aquatic facility at a future joint meeting between the City and the School District.

Background:

At the last joint meeting between the School District and the City, staff provided a brief report on the feasibility of a joint effort in establishing a new aquatic center to serve the citizens of Visalia on a year-round basis.

As outlined at the February 27, 2006 meeting, the El Diamante swimming pool is projected to open to students in the (Fall of 2006 or the Spring of 2007). The pool will be available as part of the City's summer recreation program in the summer of 2007.

As Visalia continues to grow, City staff is suggesting that a comprehensive analysis be given to the future aquatic programming needs of a growing community. It is projected that if planning efforts begin now, the next major community aquatic facility could open in four or five years, providing a funding strategy is implemented.

Some of the points made in the last report:

 A 50 meter pool has been mentioned as a desired amenity in the community to accommodate the wishes of the competitive swimming community as well as the potential to attract regional and statewide swim meet competitions. These large swim

meets have the potential to provide a positive economic impact to the local business community.

- City staff suggested that discussions should begin regarding the feasibility of locating a new aquatic center at the proposed new middle school or high school campuses in northwest Visalia --- or perhaps another location in the community?
- One of the drawbacks of the current community recreation swim program is that it is a summertime only program --- with the general public having access to the high school pools for 9-10 weeks during the busy summer season. Access to an outdoor community pool on a year-round basis is something that is desirable by youth competitive swim programs, water polo teams, lap swimmers, citizens wishing to take swim lessons, and other potential special interest swim classes.
- The opportunities for increased attendance and revenue go up significantly if you
 consider moving an aquatic program indoors. In essence, you have a summer time
 program on a year-round basis. A "warm-water" pool can also be considered with an
 indoor facility which creates many more programming opportunities for small children,
 seniors, and the disabled.
- Other opportunities for increasing revenues, and minimizing expenses, can include zerodepth entry pools, playground equipment with water elements, and small water slides.
- According to school district officials, the additional construction costs associated with a
 50 meter pool vs a 25 meter x 33 yard pool (El Diamante) would be an additional \$5
 million in capital costs and roughly \$100,000 to \$150,000 in additional annual operation
 and maintenance costs. School district officials have indicated they do not have the
 funding for the additional costs associated with expanding a pool from a 25 meter x 33
 vard pool to a 50 meter pool.
- These topics and other ideas should be more thoroughly explored as we plan for the next community pool(s).

Establishing An Ad Hoc Committee:

Staff is suggesting that an ad hoc committee of seven (7) members be formed to study the feasibility of a joint venture to establish a year-round aquatic center in Visalia. On a very preliminary basis, the goal of the committee will be to evaluate potential sites; identify the long-term aquatic programming needs of the community; identify other potential project partners; and formulate some ideas and concepts for a new aquatic center. The proposed committee would include the following:

- 1 Member of the City's Parks & Recreation Commission
- 1 Member of the City's Disability Advocacy Committee
- 1 Member of the City's Citizen's Advisory Committee
- 1 Member of a Youth Recreation Swim Team (coach or board member)
- 1 Athletic Director (as designated by the District)
- 1 Member of the District's Facilities Advisory Committee

As the potential for this project evolves, this committee could be expanded to include other potential entities or participants. Examples include the County Office of Education, College of the Sequoias, and the YMCA.

Staff support will be provided by the City's Director of Parks and Recreation and the District's Assistant Superintendent of Administrative Services, or his designee. The plan would be to invite a few consulting firms that could provide some initial thoughts and/or recommendations to the committee on the issues surrounding the development of a new aquatic center.

At some point, if there is project support, a consulting firm should be hired to work with the Ad Hoc Committee to develop some schematic designs for a new pool complex and develop some initial cost estimates.

Riggin Avenue Extension Project:

The Riggin Avenue Extension Project consists of roadway improvements that will connect Riggin Avenue between Dinuba Boulevard and the west end of St. Johns Parkway as an arterial status roadway (ninety feet curb to curb.) Once completed, the segment of roadway will provide an east/west connection on the north side of Visalia between State Route 99 and Lovers Lane. The project consists of installing a traffic signal at the intersection of Dinuba Boulevard and Riggin Avenue along with curb, gutter, median curb and median lighting. Sidewalk will be installed with adjacent development. Striping will allow for two lanes in the east and west bound directions between Dinuba Blvd. and Burke Street.

Riggin Avenue Extension Project Tentative Timeline:

- August 4, 2005 City Staff opened six (6) bids submitted for the Riggin Avenue Extension Project
- August 15, 2005 City Council awarded the Riggin Avenue Extension Project to Glen Wells Construction Company, Inc.
- September 15, 2005 Date of executed contract (contract length: 90 working days)
- September 19, 2005 Notice to proceed issued to contractor for all work outside Caltrans' right of way
- October 4, 2005 Caltrans issues Encroachment Permit for underground work only within State's right of way
- October 25, 2005 Caltrans issues revised State Encroachment Permit for underground work only

- December 27, 2005 Caltrans issues permit for all work within State's right of way
- January 31, 2006 Original date project completion
- Contract Change Order No. 1 Length of contract extended 45 working days due to weather days and Caltrans' Permit delay
- April 5, 2006 Revised notice of completion date based on Change Order No. 1

Based on current weather delays the project is anticipated to be completed within 45 working days. The contractor has all underground infrastructure in place as well as curb and gutter. Grading for the median island is necessary prior to installing the median curbing. Electrical work will follow the installation of median island curbing. The road section will be installed once the median curb is in place and all underground electrical work is complete. Once underground conduits are in place, the traffic signal will be installed while the roadway is being constructed. Based on acceptable weather conditions it is anticipated the roadway will be opened to the public by June 2, 2006.

McAuliff Street Improvement Project:

The McAuliff Street Improvement project consists of a series of improvements that will connect McAuliff Street to Mill Creek Parkway as a collector status roadway (sixty-four feet curb to curb) south of Houston Avenue. The project will consist of modifying the existing traffic signal at the intersection of McAuliff Street and Houston Avenue to allow for the fourth approach from the south. The project extends McAuliff Street south with new curb, gutter, pavement, bike path and street lights from Houston Avenue to the current end of McAuliff Street north of Douglas Avenue. Two through lanes in each direction will be provided between Houston Avenue and Douglas Avenue.

Additionally, the project constructs McAuliff Street south of Douglas Avenue to the extension of Mill Creek Parkway. The roadway will include curbs, gutters, pavement, street lights and a storm drain system that will be extended to the south limits of the project. A temporary storm basin will be constructed adjacent to McAuliff Street to handle storm water runoff from the roadway until the line is extended to the permanent basin south of Mill Creek/Evans Ditch. Along Douglas Avenue, the project will tie into improvements proposed or being installed by adjacent subdivision development.

Finally, Mill Creek Parkway will be extended east from Manzanita Street to McAuliff Street including curb, gutter, raised median island, median street lighting, pavement and sidewalk along the south side. A new traffic signal will be constructed at the intersection of Mill Creek Parkway and Lovers Lane.

McAuliff Street Improvement Project Tentative Timeline:

- April 4, 2006 City Staff opened six (6) bids submitted for the McAuliff Street Improvement Project
- April 17, 2006 City Council awarded the McAuliff Street Improvement project to R.J. Berry Jr., Inc.
- April 18, 2006 Notice of Award of Contract issued to R.J. Berry Jr., Inc.

- On or before May 2, 2006 Executed contract documents including bonding and insurance due to City
- On or before May 8, 2006 Notice to Proceed anticipated to be issued to contractor
- On or before May 30, 2006 Contractor to begin construction of the McAuliff Street Improvement Project
- On or before August 18, 2006 Contract date of completion (60 working day contract)

R.J. Berry Jr., Inc., the project contractor, has determined that procuring the traffic signal poles and mast arms will take fourteen to eighteen weeks. The order will not occur until the contract is signed by the City. Delivery of the poles and mast arms may delay the completion of the project. However, staff anticipates that the pavement will be in place and that the road will be open to traffic.


Visalia Parkway Street Construction Project:


The Visalia Parkway Street Construction Project will construct a new segment of Visalia Parkway between Demaree Street and Dans Street. This section of Visalia Parkway is intended to provide a second access for the new Cottonwood Creek Elementary School scheduled to open in the Fall of 2006 and provide better traffic circulation in the surrounding area. Visalia Parkway will ultimately have a landscaped median island with two travel lanes in each direction. The current project will construct the northern half of the roadway and provide a single travel lane in each direction. The street will be a two-lane road until full build out occurs in the future when it will become a four-lane divided roadway. Additionally, a future extension of the divided arterial roadway will cross Packwood Creek to County Center Street. The current project includes signalizing the Visalia Parkway and Demaree Street intersection and constructing transition lanes west, north and south of the intersection. In addition, paving and a median curb will be installed along the school frontage. The street is shown as an arterial street as part of the April 2001 Circulation Element.

Visalia Parkway Street Construction Project Tentative Timeline:

- February 2006 Environmental study complete
- Right of way Acquisition
 - Late September 2005 Close escrow on Story property (northeast corner of Demaree St. and Visalia Parkway)
 - Early October 2005 Close escrow on Acevedo property (northwest corner of Dans Street and Visalia Parkway)
- Late Jan. 2006 Sanitary sewer trunk line construction complete between Demaree Street and Dans Street
- Early February 2006 Topographical survey for design complete
- Mid April 2006 Roadway design complete
- April 2006 Traffic signal design complete
- April 3, 2006 City Council approves Non-Prevailing Wage Agenda Item
- April 13, 2006 Advertised project for construction bids
- May 2, 2006 Open bids
- May 8, 2006 City Council to review bids and consider award of contract
- May 9, 2006 Notice of award provided to low bidder



Subject: Progress Report on the South East Area Master Plan

Date: Tuesday May2, 2006

The Visalia City Council has initiated an effort to prepare a Master Plan for the city's southeast quadrant. The 850 acre project area is located south of Caldwell Avenue, east of Santa Fe, west of Lovers Lane and north of Avenue 272 (see attachment). The consultant firm of Moule and Polyzoides began earnest preparation of the Master Plan during a one week "charrette" (intensive public work session) from April 9th thru 16th. School staff and city staff participated in meetings with the consultants prior and during the charrette to discuss applicable school and land use planning issues. An elementary school site was conceptually located near the center of the master plan area in accordance with school staff discussions.

A Draft Master Plan document will be presented to the city within 60 to 90 days for public review and comment. School district staff and city staff will have will have an additional opportunity to comment. There will also be public meetings later in the process to allow further public comment during the Planning Commission and City Council Public hearings.
