The 2008 financial meltdown changed cities, exacerbated by historical State takeaways totaling \$40 Million in the last 5 years.

Police Staffing Has Remained Constant, But:

- Homeless demands have risen dramatically
 - 200 to 3,400 in the last decade
- 911 calls have risen twice as fast as population
 - 14,000 over the last year
- Prop 47/Realignment has more criminals on the street
- Felony property crimes are now misdemeanors
 - Thefts less than \$950 are misdemeanors



The Mileage of Streets Has Increased, But:

- State street funding has decreased
- Street maintenance costs \$0.20 a square foot when in good condition, but \$4 a square foot when poor

Fire Staffing Has Remained Constant, But:

- Equipment has aged without replacement options
- Maintenance of equipment keeps insurance rates down

Working to Meet Growing Demand

Citizen Demand & Community Needs Have Grown:

- Calls have increased with population
- 911 calls have increased faster than population
- Average 911 response times have risen from just under 6 minutes in 2013 to 7 minutes in 2015

Staffing Needs:

- Maintain officers on the street to proactively prevent crime
- To reach 40-50% proactive time, City would need to add 23 officers/neighborhood patrols to our City streets

Fire Department

Keeping Up with Calls and Equipment Needs

Goal:

Protect life and property, improve fire response times

How:

To ensure engine availability & rapid response

Maintain Ratings That Affect Citizens:

- Maintain current Insurance Services Office rating
- A lower rating would cost homeowners about \$180/year for every \$100,000 value on fire insurance, more than \$7 million dollars a year
- To keep fire engines available for structure fires, fund 2 person medical emergency response units instead of 3 person engines

City's Single Largest Asset at \$900 Million

Lack of Funding to Maintain Roads:

- 472 miles of road & 2,300 acres of pavement
- Pavement condition is "Good" to "Fair"

Current \$2.6 M/Y Budget Can't Maintain Streets:

- Costs about 20 cents per square foot to maintain "Good" condition but \$5 a sq. ft. if condition is "Poor"
- Cost \$8.2 m/yr to maintain roads at "Good"
- If not maintained, it will cost \$28 million a year, for 20 years, to move up from "Poor" to "Good"

Parks

Over 40 Parks and an Active Trail System

Quality of Life:

- Essential infrastructure component
- Parks and trails support the economy, the environment, public health, education & community cohesion.

Maintaining the System:

- Irrigation, mowing & tree trimming
- Level of Recreation programs
- Less than 5% of overall essential services plan



Looking for a Solution

Council Sought Citizens' Thoughts

- The Citizens Advisory Committee & Ballot Measure Advisory Committee
- 30 citizens met from 8/15 through 1/16
- Studied service needs & citizen desires
- Reviewed Community Survey
- Recommended ½ Cent Sales Tax: \$0.50 per \$100 or \$2.50 on a \$500 purchase

Measuring Visalia's management/efficiency versus surrounding cities:

Public Safety employees per 1,000 population

During the recession, city reduced total personnel per 1,000 population from 5.7 to 4.8 but maintained Public Safety level

Measuring Visalia's management/efficiency Visalia self-funds their health care plan

Cost per employee has risen about 4% annually since 03/04

Since 2007, employees have paid 50% of the cost of any increase in premiums

Retirees are being moved into Medicare and city supplements are being phased out

New employees since 2008, contribute more to their retirement, with a lower payout rate and later retirement age

Every City but Visalia has a Utility Tax

Value of broader base: Tulare generates \$1,030 annually from a family of 3.
Visalia receives \$616.



Citizen Group Recommendations

Focus on Maintaining, Not Adding

- Implement a locally-enacted ½ cent sales tax measure to maintain essential city services—all funds stay local
- Would not apply to food, medication, rent or mortgage
- Ensure high level of accountability:
 - Audits and Citizen Oversight
 - Budget and Reauthorization Hearings
 - Mandatory reauthorization review
- Focus on Police, Fire, Streets & Parks
