- c. With one vacancy and two people interested the committee would have to vote on the new member, instead of voting Bryan Poochigian took himself out of the vote. Therefore, leaving Susanne M. The only member with interest in serving on committee.
- d. Motion to appoint Susanne Monroe to Measure N committee made by Joel Rosales, 2nd by Jim Burr. Motion carried unanimously.

4. CAC annual Report.

- a. Staff brought to the attention of the committee the CAC annual report which would be made at a City Council meeting, date to be determined later.
- After discussion on what was needed in annual report it was decided that two individuals usually the Chairman and secretary would prefer the annual report
- c. Motion made by Don Wright to appoint Norbert and Joel lay out the initial report to present to committee at April meeting, 2nd by Bryan Poochigian Motion approved by all members.

5. Non-Profit: Sub-committee.

- e. The question was raised by Suzanne Monroe about the standing of the Non-Profit committee, with Measure N funding, some going to Non-Profits. The committee was wanting clarification from council as to the future of the CAC's involvement in the selection process.

6. Public opinion survey

- a. Presentation was Made by Amanda Dahlstrom on the status of the Public Opinion Survey and the amount of Surveys at time of meeting.
- b. Committee members wanted details on Race, Gender and Age.
- c. Those details were given and determined that the committee still needed more surveys from 18-35 year olds and 55 and older.
- d. It was also determined that the Hispanic population was not well represented in the surveys according to the demographics of the city.

- e. When looking at the area percentages the CAC needed to determine which areas we would hit I our face to face survey day. The areas that were determined were the NE and SW. A motion was made by Joe Eiben, 2nd by Bryan Poochigian. Motion carried unanimously.
- f. Motion was made by Joel Rosales to do the Face to Face in person surveys on April 7th, 2018. 2nd by Carla Calhoun. Motion carried unanimously. Sign up sheet was sent around to committee members.

7. CDBG Sub committee.

- a. Some concerns have been made about the CDBG committee. The past fiscal year the committee has done very little in the realm in which it was created. Many members have brought up concerns of the committee standings.
- A motion was made by Jimm Burr to direct Mario to clarify status of CDBG sub committee when it comes to a range of financial planning to city council. 2nd by Joel Rosales. Motion carried with one member abstaining.
