Track 21. Annual Report by the Visalia Parks & Recreation Foundation, Thora Guthrie, Executive
Director

Thora Guthrie, Executive Director of the Visalia Parks and Recreation Foundation presented the annual report which included the organization's accomplishments through events and fundraising activities. A check for \$100,000 was presented on behalf of the Foundation to the City of Visalia for the new Sports Park.

2. Request for the Visalia Police Department to join Project Lifesaver, a program to facilitate rapid location of missing persons suffering from dementia, Down's Syndrome, and autism.
Captain Rick Haskill, and Sergeant David Jarrett, Visalia Police Department showed a DVD presentation of Project Lifesaver, a law enforcement based program to aid victims and families suffering from Alzheimer's disease and related disorders. The mission is to locate and rescue missing persons. The program comes highly recommended by other law enforcement agencies.

Council Member Landers asked that options such as a GPS system be investigated for comparison of costs.
