- 2. Review and Approve the Minutes of the Regular Meetings of October 12, 2021 MOTION: Motion to approve the minutes as presented, Motion carried 4-0 Monroy/Woods
- **3.** Review of Visalia Gadabouts User Requests for Fee Waivers Discussion lead by Laurissa Roggenkamp, Recreation Manager
 - City Staff Recommendations: (In order of Staff preference)
 - 1) The Parks & Recreation Commission moves to recommend to City Council that the applicants pay direct cost of staffing and waive facility rental fee.
 - 2) The Parks & Recreation Commission moves to recommend to the City Council a full facility waiver.
 - 3) The Parks & Recreation Commission moves to deny requested applicant fee waiver(s).

- 5. National Fitness Court Campaign Presentation Presentation by Jeremy Rogers, Community Services Director
 - Commissioners were asked to submit their preferred park(s) for proposed fitness court location to the Community Services Director by 1/3/2022.
- 6. Air Quality Policy Discussion *Discussion lead by Jeremy Rogers, Community Services Director* Director Rogers asked the commission to discuss and provide feedback on the topic of closing outdoor facilities due to poor air quality.
 - Commissioner Woods suggested adding 'under certain condition' into the City's Park Ordinance and Community Services User Agreements limiting park use, with appropriate terminology
 - Commission Chairman Woods suggested inviting someone from the Tulare County Air Quality Board to do a presentation to provide data

- Commissioner Walsh added that the information was available through San Joaquin Valley Air Pollution Control District app
- Because the Community Services Department uses the data from San Joaquin Valley Air Pollution Control District to determine internal program actions based on air quality, Commissioner Woods suggested using those same criteria from that resource for consistency; and use the data numbers to determine that external activities to not be allowed to take place as well.
- Commissioner Woods added that it should be included in the contract that when we're in contract with a larger organization that dictates whether they will or won't conduct activities their contract needs to state that they will take full financial responsibility for anything that happens based on the air quality conditions.
- Commissioner Woods suggested an air quality widget from the San Joaquin Valley Air Board that could be added to the City's website.
