Visalia Parks & Recreation Commission Meeting Minutes January 11, 2022

Call to Order/Roll Call

The Visalia Parks & Recreation Commission met in a regular meeting on Tuesday, January 11, 2022, at City Hall West located at 707 W. Acequia Avenue, in the Council Chambers. The meeting was called to order by Commission Chair Steven Woods at 5:30pm.

- 2. Review and Approve the Minutes of the Regular Meetings of December 14, 2021 MOTION: Motion to approve the minutes as presented, Barajas/Woods; Motion carried 4-0
- 3. Introduction of Daryl Tillman, Parks Maintenance Supervisor, Alvin Dias, Parks & Facilities Manager
- 4. Review and Make Recommendation for the 2022 Race Schedule for Plaza Park Raceway, Laurissa Roggenkamp, Recreation Manager
- **Recommendation:** City staff recommends that the Commission provide conditional approval the proposed 2022 Plaza Park Raceway schedule as submitted and authorize the Director of Community Services to issue a permit for the days and times specified on the schedule pending City Council's approval of the Operations and Management Agreement.
 - Commissioner Woods requested to meet with Parks Maintenance Supervisor Daryl Tillman and Community Services Director Jeremy Rogers in April to discuss the Plaza Racetrack maintenance issues and discuss next year's contract with maintenance and upgrades as part of the contract.
 - Commission Walsh asked if piping for reclaimed water was provided to the racetrack. Parks & Facilities Manager Alvin Dias explained that this piping goes to the pond; that it still needs to be changed over to use the reclaimed water.

- 5. Trail and Bike Paths End of Year Update 2021, Casey Chu and Diego Corvera, City of Visalia Engineering Division
- Commissioner Walsh asked if City staff has worked with Google to get online trail maps or bike routes for Visalia. Mr. Corvera will make note and investigate.
- 6. Authorization of Letter of Support for Recreation Park Enhancement Project Clean California Local Grant Program, Casey Chu, City of Visalia Engineering Division
- Commissioner Walsh asked about groundwater sustainability at the Recreation Park location. Mr. Chu said that the parking lots will remain asphalt to drain water into the bios wells.
- Commissioner Woods expressed concern for the pavement alternatives of the grant and wants to make sure that there's balance for the needed pavement with other structures and landscaping.
- Commissioner Wagner asked if the 'walk' in the rendering would impede on the access of the ballpark that looks to be where materials are delivered. Mr. Chu said that they would investigate.
- MOTION: Authorize letter of support from the Parks and Recreation Commission for the Recreation Park enhancement project. Woods/Wagner; Motion carried 5-0
