Agenda

Conditional Use Permit No. 2023-14: A request by California Water Service Company to amend Conditional Use Permit No. 2012-09, by amending a one-million-gallon capacity water tank height and width dimensions depicted within the previously approved Conditional Use Permit No. 2012-09. The project site is zoned R-1-5 (Single-Family Residential 5,000 square foot minimum per lot). The project is located at 738 North McAuliff Street. (APN: 103-320-056).

Recommendation

Staff recommends that the Planning Commission continue the continued Public Hearing Item No. 6 from the April 24, 2023, Planning Commission Agenda based on the applicant's difficulty in coordinating a site visit with California Water Service Company (CalWater) staff from out of the area.

Summary:

At the April 24, 2023, Planning Commission meeting, the Planning Commission granted a request to continue Item No. 6 Conditional Use Permit No. 2023-14 to the May 8, 2023, meeting at the request of the applicant. The request to continue the item is to allow the applicant to work with City staff on identifying measures to reduce the visual impact of the 35-foot water tank. Although landscaping was planted when CalWater developed the site minus the water tank, CalWater staff is seeking additional screening options to address concerns raised during the public hearing.

A site visit with CalWater staff from out of the area along with City staff is set for May 9, 2023. After the site visit, representatives for the water service will work to formulate a better screening method for the proposed tank and produce exhibits for the Planning Commissions review at a future meeting. Once a public hearing date is identified, staff will re-notice the conditional use permit for the future public hearing date.

Continuing the item to a date uncertain will require that the conditional use permit be renoticed once a new public hearing date is identified. Public hearing notices will be sent to the local newspaper, properties owners and tenants within 300-feet of the project site, and any interested individual(s) that requested to be provided a public hearing notice related to this item. Please note, the public hearing notice will only be advertised and mailed if the conditional use permit is to be considered at a future public hearing.
