Review and consider Council approved amendment to the Measure N Plan to fund fire positions - Finance Director Renee Nagel presented the item and addressed questions regarding the recommended amendment to Measure N. A motion was made to move \$400,000 in fire positions to Measure N from Measure T. (BP, JA) 6-1 (Vincent Salinas no)

City Manager Randy Groom provided an introduction to the item because Council has done something different with this item and is asking the Oversight Committee to provide some feedback to the proposed squad concept, rather than just reacting to a proposed plan or amendment. He will take back the feedback from the group, and Council will make a decision on what to propose to the Committee for formal consideration. He also discussed the squad concept as presented in Measure N.

Battalion Chief Dustin Hall presented the proposal for the Squad Working Group. The Committee asked a number of questions. Some of the individual comments included:

- Should it be a battalion chief or could it be a different position? Nurse, Deputy Chief, etc. Does it have to be a sworn position?
- Should we stop having fire fighters running medical calls?
- Having 9 paramedics supervised by a single BC could be seen as the same as a current work load of a BC.
- The Plan would be good, but it needs to be tweaked with regards to the supervision. (Consensus)
