Mayor Gamboa referred Mr. Ala to the Public Works Department to address his specific concerns. 2) Tim Fosberg, Caldwell Avenue, asked the Council not to postpone the prefunding of the Retiree Health Benefit costs. 3) Dominic Prado, Demaree Street, asked the Council to consider long-term planning to alleviate social issues in the City. Mayor Gamboa referred Mr. Prado to Police Chief Carden and Parks and Recreation Director Elizondo for further information and invited Mr. Prado to join committees and attend Council meetings in an effort to become informed on what the city is doing on these issues.
