#### Public Comment on Work Session and Closed Session Items -

Tracks 3 & 41. Presentation by Great Lakes Airlines regarding new airline service from Visalia to Ontario<br/>beginning September 8, 2008.

Monica Taylor representing Great Lakes Airlines, updated the City Council on the new air service from Visalia to Ontario, CA which will begin on September 8. There are approximately 30 destinations that can be reached directly from Ontario. Tickets can be purchased from FlyGreatLakes.com, Expedia, Orbitz, and Travelocity as well as through travel agents. The Council expressed their excitement about the beginning of the air service.

Track 2 2. Visalia Police Department update on Gang Suppression, Intervention Prevention strategies and gang violence update for 2008

Police Chief Bob Carden, and Lt. Jason Salazar updated the City Council on efforts to break the gang cycle in Visalia. The suppression efforts are the result of a multi-agency approach with support from the business community. As a result of civil gang injunctions the city had an 18.5% reduction in gang violence from January-July 2008.

Council questions were answered by Lt. Salazar and Chief Carden and the Council commended the Visalia Police Department on its efforts in this area.
