Chris Tavarez, Management Analyst, reviewed the recommendations regarding pay for parking in structures and discussed the parking structure maintenance is funded by the General Fund. Eric Bons, Senior Civil Engineer, discussed the recommendations regarding on street parking opportunities and parking signage for parking structures.

AS/SN 5-0 - authorize staff to continue to survey the downtown area to increase parking where feasible.

SN/WG 4-1 (Link – No) – authorize staff to complete further study and cost analysis for charging in the parking structures and changing parking enforcement hours and to include input from the Police Department.

WG/SN 4-1 (Link – No) – authorize additional study on the development of a tiered parking citation policy and to include input from the Police Department.
