WEST HIGHWAY 198 CORRIDOR CONCEPT MOVES FORWARD: Visalia

City Council and Planning Commission members approved a package of proposals which, in part, starts a process to preserve a "scenic corridor" for motorists entering Visalia from the west along Highway 198 and allows consideration of future land development opportunities in the areas on both sides of the corridor. With Vice Mayor Amy Shuklian dissenting, Council and Commission members authorized staff to proceed with incorporating the area referred to as the West Visalia Highway 198 corridor, from Goshen Avenue on the north to the Visalia Parkway extension on the south, into the General Plan update process. They also approved the following: A 200-foot setback area for properties currently within the City limits located on the north side of Highway 198, east of Shirk Street; Parks and Recreation Commission to study and make recommendations to the General Plan Update Review Committee on a detailed boundary area for the open space component of the Corridor for properties currently under County jurisdiction, and develop an open space corridor design for the setback area. Council members will consider authorizing the use of park impact fees to pay for design efforts and potentially hiring a landscape architect to assist in the design effort.

OTHER NEWS: The City Council and Planning Commission simplified the development process for the Business Research park zone, along Plaza Drive north of Highway 198.

COUNCIL APPROVES CONTRACTS FOR TWO NEW CITY PARKS: City

Council members approved awarding two contracts for the development of Lions Neighborhood Park and Mill Creek Garden Park. BMY Construction Group in Fresno was awarded a construction contract for the development of Lions Neighborhood Park in the amount of \$652,194, and Hobbs Construction in Clovis was awarded a contract for the construction of playground improvements at Mill Creek Garden Park for \$138,756. Mill Creek Garden Park, at Lover's Lane and Mill Creek Parkway is a heavily used neighborhood park/storm pond basin with no playground amenities available to the area residents. The project will include the addition of new playground equipment, a pedestrian pathway, seating areas, irrigation upgrades, landscaping and security lighting.

BUILDING PERMITS DROP SLIGHTLY WITH MARCH NUMBERS: After

showing a gain in the first two months of 2010 over last year's number of building permits issued, March numbers slipped slightly to show a 9 percent decrease in the total number issued—from 763 in 2009 to 694 in 2010. Single family dwellings permits were down by 9, from 113 in 2009 to 104 in 2010 for January through March. Permits for new commercial projects were down by 43%, from 14 in 2009 to 8 for the first three months of this year. The total valuation of all permits was down 36%, from \$46,322,254 in 2009 to \$29,603,299 in 2010.
