SEALS/BIEHLE AWARDED \$2 MILLION CONSTRUCTION CONTRACT

FOR TRANSIT MAINTENANCE FACILITY: At its May 3 regular meeting, the City Council authorized the Transit Division to award the construction contract for the Transit Operations & Maintenance Facility expansion in the amount of \$2,070,000 to Seals/Biehle General Contractors of Visalia. The City will use \$1.1 million in American Recovery and Reinvestment Act (ARRA) grant funds that were left over from the Transit Center expansion project toward the Operations Facility. The remaining funds will come from the Local Transportation Fund initially and be replaced by Prop 1B funds that the Transit Division is programmed to receive as the State is able to sell bonds. Both the LTF and Prop 1B funds are not scheduled to be used for any other purpose until the Prop 1B funds are received, at which time the LTF funds can be redirected to other capital or operating expenditures.

OTHER COUNCIL ACTIONS: City Council also authorized a contractual agreement with Quad-Knopf for \$27,450 for consultant services for the Mooney Boulevard Corridor Zoning Study. The study is intended to identify practical zoning measures that the City could implement with very little public cost to encourage more appropriate, practical development and remove inappropriate/outdated "zoning barriers" for projects along the Mooney Corridor.

BUILDING PERMITS HOLD STEADY WITH '09: As of April 30, 2010, the total number of permits issued in the City was 2009, one ahead of the total for the same time period in 2009. A total of 1,009 permits have been issued since Jan. 1, at a value of \$40,743,087. For the same time period in 2009, 1,008 permits were issued at a value of \$54,508,325, about 25% higher value than this year. New single-family dwelling were down 3%, from 139 in 2009 to 135 in 2010. Residential additions were up 12% from 258 in 2009 to 289 in 2010.

OPENINGS ON COMMITTEES, COMMISSION: The City of Visalia is accepting applications from interested citizens for its City committees and commission.

- Citizen's Advisory Committee Acts as a liaison between the general public and the City Council concerning community issues. The Committee has openings for three alternate members.

BOOK NOW FOR SEQUOIA SHUTTLE'S FOURTH SEASON: Sequoia Shuttle starts its fourth season of public transportation from Visalia to the majestic Sequoia National Park on May 27th. To date, the partnership service between the City of Visalia and the National Park Service has transported close to 15,000 patrons. The \$10 roundtrips, for trips taken before June 11th (not including weekends and holidays), is perfect for those looking for an easy get-away from the heat for themselves or their families.
