Details: On listed date the Visalia Police Department in conjunction with CVS Pharmacy conducted a detail which resulted in the arrest of 13 suspects. CVS Pharmacy's loss prevention had reported a loss of \$117,000 in merchandise over a six month period. The investigation revealed that Suspect Amanda Hooley and Suspect Valerie Martinez, who were employees of CVS Pharmacy, were allowing the other suspects to enter the store and take merchandise without paying. Last night members of the Visalia Police Department and CVS Pharmacy Loss Prevention conducted surveillance of the store and observed 11 of the suspects taking property without paying for the items. As a result of the investigation 13 suspects were arrested and \$4700.00 worth of merchandise that was stolen during the operation was returned to the store. The Visalia Police Department also towed 5 vehicles that belonged to the suspects. The investigation is continuing to determine if other suspects may have been involved in past burglaries.




