

FEDERAL LEGISLATION COULD ALTER FLOOD INSURANCE RATES:

City staff updated City Council on reauthorization legislation for the National Flood Insurance Program, including efforts by the City's representative to include provisions for increasing private insurer involvement. Language would need to be strengthened to call for a mandate that federal and private mortgage holders must accept authorized private insurance as equivalent to insurance available through NFIP. Private sector competition could benefit Visalia and other communities by providing lower costs for flood insurance. Council lauded Rep. Devin Nunes and his staff's efforts to insert legislative language in the bill that would help Visalia. The bill is in its early stages in committee, and to date, no legislators have signed on as sponsors. For more information on the staff update, click here.

OTHER COUNCIL NEWS: Staff and board members of the Visitors and Convention Bureau presented its annual report, which shows the organization has booked business that has, or will in the future, bring \$1.54 million in direct revenue and have an economic impact of \$8.1 million. The City funded the Bureau in 2010-2011 with \$254,000 and provided in-kind services.
