Ruth Caesar discussed her concerns about the artwork on the Santa Fe Bridge and the artwork proposed for the Plaza Park bridge. Mayor Link responded and discussed the public participation process

1. Retiree Healthcare Funding Policy. Resolution 2011-17 required.

Eric Frost, Administrative Services Director, presented the background and staff proposal which would continue to give retirees access to healthcare but at full cost after a four-year phase out process.

The following persons addressed the Council:

Tammy Price, Road 196, requested longer phase out period; Debbie Braley, Acequia, concern about the word "subsidy" used in the newspaper and staff report; Mike Stow options that would allow retirees a longer opportunity to plan; Jim Thompson, N. Cottonwood St., need a longer phase-out period; Mario Cifuentez, W. Whitendale, representing Group E, requesting a longer phase out period for long term employees; Ed Lynn, representing Group A, requesting a longer phase out period and encouraging employee groups to work together for a solution; Bruce McDermott, deal with the issue in a more benevolent manner; Mike McGee in favor of a longer phase out period; Bob Braley, Acequia, benefits for those that were hurt on the job and have less than 15 years service; Mike Stow considerations for disabled and survivors insurance; Jim Thompson annual increases not part of consideration.

No vote was taken on the proposal, Council members agreed to give staff time to come up with options for retirees, and also agreed on the following: Full cost of the retiree health care will be determined on a three-tier basis of single, two party and family; Exceptions should be made for those retirees with a lesser income, and; the City's contribution will be phased out.

Adam Ennis, Assistant Director of Engineering, presented the history of the bike plans in this area which date back to 2006 and responded to Council comments and questions.

The following persons made public comments: Michael Tellian, discussed that there is too much traffic on Mineral King and Noble for bike lanes and suggested allowing parking at certain times of the day; Joshua Hickey, Denton Ct., consider the greater Visalia community interests; Laurie Reeves, on behalf her father Roy Claiburne, in favor of bike lanes on Mineral King and Noble; Herb Simmons, Mountain St., in support of the bike plan; Debbie Bowen, W. Seiger, in support of bike lanes; Carol Enns, S. Central, supportive of bike lanes; Ed Evans, Re-Max Realty, urged the Council to make a commitment to commerce in the community and oppose bike lanes on these streets; Barry Smith, W. Noble, opposed to bike lanes and suggested shared parking during certain times; Bill Balsley, S. Sol, in support of the bike lanes; Bob Brown, in support of the bike lanes which are east/west connectors; David Shelburn, W. Howard, in support of the bike plan; Richard Garcia, LaSalle, in support of bike lanes and east/west connectors; Dale Simmons, in support of bike lanes; David Jerritt, Pipkin Agency, in support of shared use; Rocky Pipkin, regarding city liability for accidents and in opposition to bike lanes; Margaret Balsley, S. Sol, need to plan for bicycle traffic.

Councilmember Gubler commented that the roads are not designed for cars and bicycles and that he supports shared usage.
