

COUNCIL APPROVES ADDITIONAL COSTS FOR DESIGN OF PLAZA

DRIVE WIDENING: Council members approved allocating an additional \$884,350 for the design for the Plaza Drive widening project in west Visalia. The original design plans were made in 1999, according to city of Visalia documents. The change in cost is because of additions to the project requested by the state Department of Transportation, as well as changes in predicted traffic flow, as the original plan was made 12 years ago. The additional money won't come from the city but from other sources, such as Measure R, a county-wide sales tax for needs. The design is expected to be complete by June 10 and construction to begin either the end of this year or beginning of 2012. The entire project should take about 18 months. The Plaza Drive widening project was initially estimated at \$8.9 million, but as the years went by and the plan grew, that cost has grown to \$29 million. For more information, click here.

VALUES UP, NUMBERS DOWN IN BUILDING PERMITS ISSUED: While the total number of building permits issued so far in 2011 was down 11%, the value was up by 36%. The number of permits issued in 2010 was 1,009, compared to 902 for year-to-date in 2011. The valuation was \$40,743,087 in 2010—up to \$55,603,201 in 2011. Increases in number of permits issued were seen in residential additions and alterations (327) and valuations for new commercial (up 914% with \$30,364,000) and commercial additions, alterations and signs (up 40% with \$9,884,287).
