Department Recommendation

Staff recommends that the City Council review the applications over the weekend, and by noon on Monday, provide in writing to the City Clerk the names of the four candidates each believes to be best suited to fill the interim vacancy. The Clerk could compile and publically announce the results, including the designations from each individual Council Member. Based on the results, the City Council could discuss how best to proceed with the process. Staff recommends setting a process that would result in someone being appointed prior to, and with enough time to prepare for, the July 18 City Council meeting

Options the City Council could consider include:

- *Schedule interviews, possibly on June 27, 2011 beginning at 4 p.m. It is suggested that the interviews be scheduled for 20-30 minutes. Council could direct staff to develop a list of possible questions that the Council could use to supplement their own questions.
- *Make an immediate appointment based on the letters of interest
- *Extend the time to file a letter of interest
- *Leave the position vacant until the November 2011 election

Department Discussion

Mike Lane resigned from the Visalia City Council effective May 31, 2011. In accordance with the City Charter (Article VI, Section 14), the City Council may choose to appoint someone to fill the position until the conclusion of the November 2011 election. Regardless of whether an appointment is made, staff recommends the Council take steps to call the special election to fill the vacancy on a permanent basis, so that the special election can be held concurrently with the general council election this November. (Later on this agenda, the City Council will be asked to consider a resolution that will include this unexpired term on the November election ballot.) .

Article VI, Section 14, of the Visalia Charter provides:

Vacancies in the Council: Any member of the Council who is absent from all meetings thereof for two consecutive months, unless excused by the Council, shall forfeit his office. Any vacancies occurring in the Council may be filled by a person appointed by a majority vote of the whole Council. Said person appointed shall serve until his successor is elected and qualified. Such successor shall be elected at the next regular election at which members of the Council are chosen, provided there is sufficient time to nominate and elect such successor at said next regular election. (Underline added.)

In summary, these provisions allow for an interim appointment, with the appointee to serve either until a permanent replacement can be selected at the next regular election, or for the full remainder of the term if there will be no regular election occurring prior to the expiration of the term. In this case, there will be an opportunity to hold a special election to select a permanent replacement, as regular council elections will be held on November 8, 2011. There is "sufficient time to nominate and elect such successor" (as provided in the Charter) at the November 8, 2011 regular election - the deadline under state law for adding the unexpired term to this election is not until July 15, 2011. Therefore, if an appointment is made now, the Charter dictates that the appointee serve only until a permanent successor is selected at the November 8, 2011, election.

(The above provisions of the Charter related to filling vacancies apply to the present circumstance, rather than slightly different provisions of state law applicable to general law cities, because in the event of a conflict with the general state laws on the topic of selection of council members, the provisions of the Charter prevail.)

If the Council chooses to select an appointee, and can agree on an appointee by majority vote, that appointee will serve until a permanent successor is selected at the November 8, 2011, general council election. The appointee is free to, run for election in November, but is not obligated to run. Whether the appointee runs for election or not, the three seats up for election in November will be determined according to Charter provisions (Article V, Section 3): the two candidates receiving the most votes will be seated to full four-year terms; the candidate receiving the third most votes will be seated to the remainder of Mr. Lane's term, which runs until November, 2013.

Appointment Process

At the last City Council meeting, the Council voted to ask qualified Visalians to submit letters of interest by noon on Friday, June 17 if they were interested in being appointed to the City Council. This information was provided to the media, and was distributed via email to a broad base of people including those on the City Council agenda list, the Inside City Hall Newsletter list, Committee and Commission members, and a number of organizations.

Forty-two letters of intent were filed by 12 noon on Friday. Attached is a list of the people, in alphabetical order, who submitted a letter of interest in accordance with the deadline. One letter was received after the deadline and is not being included for consideration. The City Clerk's Office attempted to confirm voter registration prior to the release of this staff report; however, staff will not be able to confirm those for whom there is a question on their voter registration until Monday. Those in question are noted on the list as follows:

*1 – Residential address does not match voter registration roll address

- *2 No home address listed on letter, but name found on voter registration roll
- *3 No home address listed on letter, and no name found on registration roll
- *4 Not found on voter registration roll
