Leslie Caviglia, Deputy City Manager, discussed the Council's options for processing a possible appointment to fill the current vacancy.

Councilmember Nelsen expressed concerns about some candidates being chosen based on name recognition or their ability to articulate well in a written format and he supports waiting until the general election in November. Councilmember Gubler expressed his opinion that it is necessary to fill the vacancy with an appointment to have full membership of the Council until the seat can be filled by election. Vice-Mayor Shuklian indicated she prefers to wait until the general election in November. Mayor Link discussed that if someone is appointed now they will need to run for election in November.

Councilmembers each presented their short-list of persons from the 42 that applied that they believe to be best suited to fill the interim vacancy. The combined list included 11 names. Council discussed the process to either narrow down the selection or interview each of the 11 persons and decided to interview only the 5 persons whose name appeared on more than one of the short-lists. The persons to be interviewed are: Don Sharp, Luke Feldstein, Jim Robinson, Milton Morrison, and Adam Peck.
