Details: 10/09/11 at approx. 2000Hrs VPD officers responded to the 1400 blk of W. Vassar for a call of a residential burglary in progress. Responding officers observed the suspects fleeing the area upon their arrival heading to apartments in the 1500blk of W. Walnut ave. With the assistance of a VPD canine, Soliz was found in a neighboring backyard and Mendez was found in an apartment building's laundry room hiding with her two children ages 6 and 4. A search warrant was subsequently served at Soliz and Mendez's joint residence which resulted in the recovery of the victim's property. Both Soliz and Mendez were arrested for burglary and booked into their respective facilities. The two children were released to Child Protective Services.

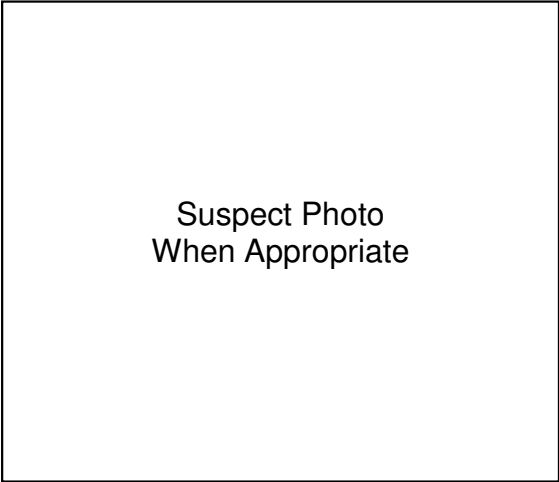
