

## Applications Available for Visalia Member of Measure R Citizen Oversight

**Committee:** Applications are now being accepted for a Visalia representative to the Measure R Citizens Oversight Committee. Applications, available on the City of Visalia's website at www.ci.visalia.ca.us, will be accepted until 5 p.m. Friday, Jan. 27. Applications may be mailed or handcarried to Administrative Assistant Gladys Ruiz at City Hall North, 425 E. Oak Ave., Suite 301 in Visalia, or by email to gladys.ruiz@ci.visalia.ca.us. The vacancy of the Visalia representative on the committee is the result of the untimely death of Karen Cooper. The individual will be appointed, at the recommendation of the Visalia City Council, by the Tulare County Transit Authority to complete Ms. Cooper's term through July 31, 2012, and would be eligible for reappointment. the Measure R Expenditure Plan calls for a 16-member Oversight Committee to provide input on the implementation of the plan. Those interested in applying must be at least 18 years of age and reside in Tulare County. Committee representatives may not be elected officials or an employee of any State, County, or local City agency. All members also must submit the appropriate Fair Political Practices Commission financial disclosure statements. The Oversight committee meetings are held at noon on the second Monday of the month in February, May, August and November, and locations may vary. City's Gang-Related Violence Drops: A comparison of gang-related statistics in 2010 to 2011 show a drop in gang-related violence of 50%. Gang-related homicides have dropped 25%, gangrelated assaults with deadly weapons down by 56%, and gang-related shots into inhabited dwellings are down by 44%. The Visalia Police Department credits the Tulare County District Attorney's Office for successful prosecutions of violent gang crime, along with community-based organizations and other law enforcement agencies working together.



Public Opinion Survey Results: Members of the Citizens Advisory Committee presented results of the annual Public Opinion survey to Council members at the Jan. 17 meeting. To help in diversifying the sample and promote geographic balance, supermarkets were selected from each quadrant of the city. A total of 342 surveys were taken on October 15, down slightly from last year's survey tally of 395. One new question of concern this year was about Elections at large or by district.
