














Message from the Chief

On behalf of the members of the Visalia Fire Department, I am pleased to present you with the 2011 Annual Report.

This report to the community highlights the activities, goals, and accomplishments of the Visalia Fire Department for 2011. I am proud of the contributions the members of this organization have made to our community. Labor and management have worked together to continuously evaluate and improve the quality of our core services. We could not have achieved these goals without the support of our elected officials.

In spite of the economic challenges faced by our City, we continue to receive the funding needed to carry out our mission. We stand with our City Council and City Manager in their efforts to make Visalia a safe and prosperous place to live.

Today's fire and rescue service has made significant progress toward the prevention of fires. One of the most important examples of this progress is the recent adoption of statewide requirements for the installation of automatic sprinklers in every residence constructed after January 1, 2011. We have also made strides toward improving emergency response, specifically, in the rescue and hazardous materials disciplines. The Visalia Fire Department was recognized by the California Emergency Management Agency (CAL EMA) in achieving a Type 1 Hazardous Materials Response Team distinction as well as a Type II – Medium Rescue Team distinction. Both of these teams are now available to respond both locally and statewide for assistance. Another area of success is in our code enforcement efforts. We have worked cooperatively with various City departments such as, police, building and code enforcement, to ensure safety issues in our community are dealt with in a safe and timely manner. These efforts have had a dramatic positive effect in our community, making it a better place to work and live. Here in Visalia, we take pride in keeping up with the latest trends and standards in order to meet our mission to "Dedicated to protecting all through excellent service".

In 2011, we ran over 11,000 calls for service. With the majority of those calls for service being medical emergencies, our ability to provide a paramedic within an average time of 5 minutes has proven to save lives.

The VFD provides all-risk emergency response and a wide array of community services with an authorized staff of 72 professional Firefighters, Fire Inspectors and Support Staff. In the following pages, you will be introduced to the various divisions and programs which contribute to the health and safety of our community. I hope that you find the information contained in this report interesting and useful. It will help you get a better idea of who your firefighters are and what they do for you on a daily basis.

My personal thanks go out to all the members of this Department and to the staff who have worked together during this past year to provide exemplary service to our citizens and contribution to the quality of life in our community.

It is my hope that the next several years are prosperous for the City of Visalia, in spite of our current economic challenges. The members of the Visalia Fire Department sincerely thank you for taking the time to read this report.

Since I have been with the fire department I have come to understand a little more about the fire service and the organization. The degree of professionalism, care and dedication every person demonstrates is very admirable.



I look forward to another prosperous year, serving the community alongside the fine and dedicated people of the fire department, whose actions and accomplishments can only be defined as remarkable.



VISALIA FIRE DEPARTMENT ORGANIZATIONAL STRUCTURE



Fire & Emergency Management Department

MISSION

Members of the Fire Department guarantee to the People of the City of Visalia that we will provide dependable service in a responsive manner, while showing care and compassion for those in need. We will protect lives, property and the environment through fire suppression, rescue, disaster preparedness, code enforcement, community education, medical care, and hazardous material mitigation.

The members of this Department, working together, will provide a professional and caring environment that is fair, honest, ethical, and treat all individuals with respect and dignity. The Department will provide innovative and effective leadership in developing concepts that will be supportive of and responsive to the needs of City Government in a loyal and cooperative manner.

DESCRIPTION

The Fire and Emergency Management Department consists of five divisions:

- 1) Administration/Support Services
- 2) Emergency Services/Operations
- 3) Fire Prevention
- 4) Training
- 5) Hazardous Materials Response.

The Administration/Support Services Division is staffed by the Fire Chief, Administrative Fire Officer, City Safety Officer, Senior Administrative Analyst and Administrative Assistant and is responsible for the administrative activities of operating the department. Administrative activities include such items as financial coordination to ensure the effective and efficient use of the department's resources; promotions and recruitments; the City Safety Program; productivity measurement; and coordination of the department's programs and policies.

The Emergency Services/Operations Division is staffed by three Shift Battalion Chiefs and is responsible for protecting life and property in emergency situations by providing effective fire, rescue, and Advanced Life Support (ALS) emergency medical protection. All fire units are staffed with a minimum of one paramedic. The division ensures the maintenance and enhancement of department personnel firefighting and emergency medical skills. This division is also responsible for the Citywide Emergency/Disaster Preparedness Program, which includes ensuring the City has an Emergency Operations Plan and a functional Emergency Operations Center. Other programs managed by the Shift Battalion Chiefs include the Cal EMA Type II Medium Technical Rescue Program, Department Safety, Grants, Staff Reports and Dispatch Liaison. Additionally, the Emergency Services/Operations Division oversees the activities of the Cal EMA Type I Hazardous Materials Response Team within the Haz Mat Division. With equipment acquired largely through State grants and private donations, this team responds to various types of hazardous materials spills or incidents in our community. The team is also under contract to surrounding cities and agencies in Tulare and Kings Counties to respond to their Haz Mat incidents on a cost recovery basis.

The Fire Prevention Division is staffed by the Fire Chief, who also serves as the Fire Marshal and an Assistant Fire Marshal who oversees the day to day operations in the Prevention Division as well as an Office Assistant, one fulltime Fire Inspector and two hourly Fire Inspectors. This division seeks to ensure the safety of life and property within the community by inspecting businesses for potentially hazardous conditions, providing fire and life safety public education by coordinating community relations and public education programs, conducting fire and arson investigations, and assisting with coordination of fire code compliance on State mandated inspections and new development.

The Training Division is staffed by an Administrative Battalion Chief and is responsible for the development and maintenance of a training program to increase and enhance the response capabilities of the Fire Department, as mandated by State and Federal Standards.

DIVISION ACCOMPLISHMENTS

FIRE ADMINISTRATION—22221

2010-2012 Accomplishments

- The Measure T plan has been revised to build a fire station in the southwest area of the City
- TeleStaff scheduling, time and attendance system has been implemented
- The department added an Administrative Fire Captain, transitioned the Training Captain's position to an Adminis trative Battalion Chief and transitioned the Senior Fire Inspector position to an Assistant Fire Marshal.
- The department completed 20 Standard Operating Guidelines (SOGs)
- Staff updated the Haz Mat Response Agreement with five of the eight agencies in Tulare County
- The department evaluated auto and mutual aid agreements and submitted a report to the City.
- Completed the City's Hazard Mitigation Plan
- Staff has completed an analysis of several options for Advanced Life Support (ALS) transport opportunities
- The department applied for the following grants in 2010/11 that will help support the Visalia Fire Department:
- o LEAP (Local Energy Assurance Plan) Awarded \$200,000 grant
- o SAFER Grant for 9 Fire Personnel—two applications have been made; waiting on possible award notification

EMERGENCY SERVICES/OPERATIONS—22222

2010-2012 Accomplishments

- Staff was authorized to purchase one engine with Measure T money; this has been completed
- A new exhaust system has been installed at Station 51
- The department has evaluated and improved communication equipment this is an ongoing process, much progress has been made with the new radio equipment at Station 56 (Cal Fire facility). New radios and MDTs have been purchased and installed
- Two EOC drills have been conducted, one of which involved the California State Golden Guardian Program
- The EOC has been transitioned to the training room at Fire Station 55; staff is currently working on the installation of the emergency backup power generator.
- The department has successfully transitioned the reverse 9-1-1 system to a new vendor.
- The department fully implemented the Web Based Emergency Operations Center Program (WebEOC) has been completed and will continue to develop. Web EOC was used during the 2010 storms and worked well. The Tulare County OES (COVs portion) data base was completed in 2010, extensive training has been completed
- Staff completed most of the required National Incident Management System (NIMS) training. For the 2010 NIM-SCAST report, we had two Corrective Actions. 1. Assigned a NIMS Coordinator for each department. 2. Developed a Credentialing System. List of training requirement compliance citywide.
- o Fire Department is 100% compliant
- o IS 700 200 of 250 employees have completed
- o IS 800 10 of 80 employees have completed
- o ICS 100 200 of 250 employees have completed
- o ICS 200 200 of 250 employees have completed
- o ICS 300 29 of 58 employees have completed
- o ICS 400 5 of 20 employees have completed
- o All six fire units are now staffed with a minimum of one paramedic.
- o The Technical Rescue Team has been formed with 24 members and a new rescue trailer was purchased. The depart ment has been designated as a Type II medium rescue team through Cal EMA.
- o Staff completed all National Fire Incident Reporting System (NFIRS) required reporting

DIVISION ACCOMPLISHMENTS

FIRE PREVENTION—22223

2010-2012 Accomplishments

- Staff continues public education activities by expanding and enhancing through fire and life safety training October is Fire Prevention month; all schools (public and private) receive fire education annually serving over 6000 students
- Annual open houses were held @ three fire stations with approximately 2000 people in attendance
- Four camps were held in 2010/11 with over 150 youth participating
- All mandated fire inspections were completed for 2010/11 and a total of 4034 fire safety inspections and 1006 property maintenance inspections were conducted citywide.
- One Full Time Fire Inspector, Office Assistant and 1 Hourly Fire Inspector were hired and funded primarily through inspection fees
- Staff investigated all suspicious fires for origin and cause, utilizing nine shift Fire Investigation Team members and one prevention staff member. Over 600 fires have been investigated.
- The department has purchased new prefire planning software to integrate with current Fire RMS program

TRAINING—22224

2010-2012 Accomplishments

- All mandated training has been met for Federal, State and local requirements
- The department has evaluated and improved current training program; two year training calendar, monthly training packets and implemented the Target Safety training program
- The department has marketed the training facility and has generated ongoing revenue through user agreements with fire and law enforcement agencies as well as many private companies.
- An annual schedule has been developed and implemented to ensure required training for Haz Mat response and Rescue Team members is met

HAZARDOUS MATERIALS RESPONSE—22226

2010-2012 Accomplishments

- The Haz Mat Team has gone through an 18 month process to improve its response capabilities and has been designated as a Type I Haz Mat Team through Cal EMA
- The department now has new Haz Mat user agreements with five out of the eight agencies in Tulare County
- The department continues to develop stronger relationships with all agencies.

Fire Investigations

In 2011, the Investigations Team conducted 491 Investigations

The Fire Investigation Team is responsible for investigating fires to determine cause and origin. As Peace Officers, Fire Investigators conduct criminal investigations and prosecution of arsonists. Fire Investigators also assist outside agencies with the department's Juvenile Fire-Setter Intervention Program. Through this program we extend fire safety education and awareness to juveniles and other individuals who may have been involved or participated in setting illegal fires.

The Fire Investigation Unit is also active in public education, continuing education, and illegal fireworks enforcement detail. The Visalia Fire Department has six personnel trained in fire investigation by the State Fire Marshal's Office. The Fire Investigation Unit is overseen by the Fire Marshal.

Fire Prevention

The Prevention Division covers a wide and varied spectrum of activities and programs to educate the public in Fire and Life Safety.

This division of the Fire Department provides educational programs tailored to different groups from elementary education to in-home training and education for community residents. Their goal is to foster relationships with community entities and the public by communicating the mission, goals, and the performance of the organization at different event functions.


Prevention oversees the Fire Setter Program. This program provides in-home assessments, fire safety intervention and referrals to mental health services for children who exhibit fire setting or fire play behaviors.

Prevention participates in many health and safety community events such as the Children's Festival, Career Fairs, Open House, Carnivals and other community requested events.



One of the biggest and most popular events of the year for Prevention is Fire Camp. Roughly 80 campers participate in a week filled with fire related activities.

In 2011, the Prevention Division, conducted 253 Public Education Presentations to various outside agencies, totaling 29,826 attendees. A total of 60 individuals participated in the Ride-a-Long Program. Additionally, Prevention Staff installed a total of 50 Smoke Detec-













Emergency Medical Services (EMS)

Since July 2011, Dustin Hall has served the department as the Administrative Officer overseeing the EMS Program. During his tenure in Administration, Captain Hall has improved and created many new processes.

Accomplishments

- Established Cadre of Instructors for ACLS
- Established Cadre of Instructors for PALS
- Implemented new back board system into place
- Meetings with ambulance companies AMR and AMN, discussing cohesive training and working relationships.
- Updated standard for report writing EMS
- Established standard for yearly core evaluations, skill sign offs completed
- Established standard for direct observation and sign off sheet
- Developed Protocol, Policy, Procedure Manual for each station EMS Coordinator's Office and Battalion Chief's office
- Streamlined bio-hazard

In 2011, the Fire Department responded to over 7,912 Emergency Medical Service calls.

Medical Aid response calls include emergencies such as persons experiencing chest pain, abdominal pain, general illness, and general weakness. **Vehicle accidents** include vehicle versus vehicle, vehicle versus pedestrian, and vehicle versus bicyclist. **Rescue incidents** include persons locked out of a vehicle, water rescues, over the side—low and high angle, and confined space incidents.



SAFETY PROGRAM

On September 30, 2011, the City hired Safety Officer, Angie Cantrell to oversee the Safety Program.

The City safety program has been established to promote and support a safe and healthful work environment by providing leadership, training, information, resources, policy development, and consultation services to all City employees and departments. The goal of the City's safety efforts is to provide education and guidance to prevent injuries, illnesses, and exposures while achieving regulatory compliance.

Accomplishments

- Discussions with City Management and Department Heads regarding safety needs
- The Safety Committee, which had been inactive since February 2010 has resumed regular monthly meetings.
- The Safety section of the City Intranet has been updated
- Since review of the City's written programs has begun, significant changes have been made. In particular:
- * Bloodborne Pathogens Exposure Control Plan
- * Sharps Injury Log
- * Medical Waste Disposal
- * Emergency Action Plans
- In progress is the crafting or revision of the:
- * Aerosol Transmissible Disease Exposure Control Plan
- * Asbestos Management Plan
- * Personal Protective Equipment evaluation process
- * IIPP overall
- Safety Hazards reported, investigated, and abated
- Near miss investigations have been initiated. When a close call occurs in one department, an investigation, prospective solution, and recommendation can be made to other departments with similar exposures.
- Water seepage through the basement walls at the Police and Fire Dispatch was detected and remedied preventing the development of mold.
- Inspections have taken place at the Airport, City Hall's East, West & North, Convention Center, Corp Yard, Fire Stations, Parks, Police Stations, Senior Center, and Waste Water Treatment Plant.



TRAINING CAPTAIN

In April 2009, Captain Hughes elected to leave his Engine Captain assignment to fill the newly formed Training Officer position. During his tenure in the Training Division, he has developed a two year training calendar with a monthly training schedule program, implemented a Firefighter Survival Program for all Visalia Fire Personnel in 2010 and updated instructional materials to enhance the current fire suppression training. Captain Hughes also facilitates many classes at the new Training Facility and classroom with various fire professionals, motivational speakers and outside agencies.

In 2011, Fire Staff had a combined total of 17,284 hours of Mandatory and Required Training.

Visalia Fire Department Training Recruit Academy

As part of the hiring process with the Fire Department, Recruits are required to participate in an eight-week Recruit Academy. The Academy provides recruits with the most current and approved firefighting practices, holding the recruits to the highest standard of conduct to the public and their peers. The Academy emphasizes teamwork, professionalism, personal accountability, and respect for the chain of command within the framework of a paramilitary organization. - Recruits are expected to pass exams with 80% or better with only one opportunity to re-take an exam.
- Weekly Skill testing is pass/fail with only two re-take opportunities.
- There is daily homework
- Recruits are engaged in physical activity for one hour every day.
- Class Project Cadets are given a hand tool or hardware item that is in rusty, poor condition. It is expected each cadet will clean and turn in a shiny tool symbolizing how they see their future career and performance with the fire department.

Four Recruits successfully graduated the eight-week academy on April 25, 2011, as Fire Fighter Paramedics.

Each Battalion Chief has responsibility to oversee various work programs within the organization.



HAZ-MAT TEAM

On December 13, 2011, the Visalia Fire Department was recognized by the California Emergency Management Agency (Cal EMA) as a Type I – Hazardous Materials Department. The Visalia Fire Department has been involved with Hazardous Materials emergency response since 1991 and has had a recognized Haz Mat Team since 1992. The current Haz Mat Team is comprised of 21 highly trained members. Over the last 2 years, we have been working diligently to meet the high standards that have been established by Cal EMA to be recognized as a Type I – Hazardous Materials Department. The department held a Press Conference on December 21st to announce this accomplishment.



The Type I status is the highest recognized level of hazardous materials emergency response in California. Only a handful of other California fire departments have reached this level. As a Type I Team, we are able to handle any type of Haz Mat emergency including; terrorism / weapons of mass destruction, transportation emergencies, pipeline leaks, releases at chemical facilities, unknown products in the roadway, agricultural product emergencies and any other type of incident involving hazardous materials.



Cost Recovery

When the Haz-Mat team is activated to respond to a hazardous materials incident, cost recovery may be sought with the responsible party for personnel, equipment and supply cost. Since July 2011, the Haz-Mat Team has responded to seven incidents throughout Tulare County including a refrigeration leak in Cutler and chemical hazard in the City of Dinuba.

In 2011, the City billed a total of \$22,564 in fees to outside agencies, and was reimbursed a total of \$21,156.

In 2011, the VFD Technical Rescue Team worked to secure the equipment and training necessary to meet the high standards that have been established by Cal EMA to be recognized as a Type II-Medium Rescue Department.

Units Assigned to Fire Station 51



Engine 51 – Lead Engine for Station 51's response area. Responds to all emergencies; including medical aids, traffic accidents, structure & trash fires to name a few. Assists in Public Education and is Paramedic & Extrication Equipped.



Truck 51 - Lead truck responding to all 1st Alarm Assignments, Heavy Rescues, CO Alarm, Vehicle Roll Overs & "Pin-In" traffic accidents, vehicles into buildings and is Paramedic & Extrication Equipped.



Reserve Truck 251 – Is placed in service when needed to replace Truck 51. T251 is also available to be staffed on call back incidents or multiple alarms.



Reserve Engine 251 – Is utilized to replace lead engines that are out of service due to mechanical or when responding to a "Strike Team" Assignments. Engine 251 is also used on call back incidents or multiple alarms.



Utility 51 – Responds to Arson Investigations. Utility 51 pulls Rescue & Air Trailers, is equipped with a generator & some lighting, Rehab and Arson Equipment.



Air Support Trailer - Housed at Station 51 and is used to re-fill SCBA tanks for all Stations. The Trailer is mobile and can be transported to scenes to fill bottles on long term incidents. It has its own generator to be self-sufficient at scenes or can be plugged into station electrical.



Rescue Trailer – Is housed at Station 51. It is fully equipped to handle confined space emergencies, trench rescues, hi and low angle rescues, and swift water emergencies. The Trailer meets type II Medium Rescue Capabilities.

Interesting Facts – A $\underline{Fire\ Engine}$ weighs 42,740 pounds, the equivalent of 3.6 adult male elephants.

The difference between an Engine and a Fire Truck is the Fire Truck carries a ladder on top. A <u>Truck</u> weighs 66,000 pounds, the equivalent of 5.5 elephants. The Aerial ladder extends to 105 feet high.



Station 53 – Airport Rescue Firefighting Rigs are used in aircraft emergencies for suppression and extrication. These Rigs are capable of applying water, foam or dry chemical powder in an aircraft emergency. ARFF 53 carries 1,500 gallons of water, 210 gallons of foam and 450 pounds of Purple K dry powder chemical and is equipped with a generator and extrication tools. Both rigs are designed to operate either inside or outside the cab. ARFF 253 carries 1,585 gallons of water and 205 gallons of foam.






