Medicinal Marijuana and the Compassionate Use Act of 1996

This memorandum is being submitted to the City Council for its consideration in this work session. As the members will recall, the Council first considered the regulation of medicinal marijuana on October 4, 2004. There were a number of issues then raised concerning the need to regulate its cultivation, possession, use and distribution within the city limits. Our previous memorandum, attached hereto, is provided for your convenience and to avoid unnecessary repetition of our analysis of the Compassionate Use Act.

The decision of Council at that time was to wait for the determination by the United States Supreme Court of the <u>Ashcroft</u> v. <u>Raich</u> case, a case pending concerning the conflict between federal law and the California's Compassionate Use Act. Unfortunately, the Supreme Court has not yet issued its determination of the issue. The case was accepted for review by the Supreme Court on June 28, 2004. All briefing was completed and oral arguments were heard on November 29, 2004. The only explanation we can surmise from the delay in issuing its opinion is that the members of the court may be divided on the issue.

In the meantime, unless the City implements its own regulations to limit the cultivation, possession, use and distribution of medicinal marijuana, under California law, individuals and "primary care givers" are afforded, in our opinion, too much latitude, which breeds abuse of the intended cultivation, possession, use and distribution limitations imposed by the Compassionate Use Act.

Both the Police and the Community Development departments of the City are left to deal with the plethora of issues, with only the vague guidelines of the Compassionate Use Act to support them. Common to the Police and Community Development department's dealings is the non-profit organization known as Medicinal Marijuana Awareness and Defense of Tulare County ("MMAD"), a California Public Benefit Corporation operating on South Mooney Blvd. in Visalia. MMAD claims its organization has the following three (3) components:

1. Informational service to help patients or potential patients obtain a recommendation (a.k.a. prescription) and to provided those patients with a source to get their medication;

- 2. Clinical service to assist patients in determining strains of marijuana and dosages for the most effective benefit. The clinical service would also supply patients with the needed medication and would permit self-medication on the premises; and
- 3. MMAD is creating a co-op where patients or their primary care givers can cultivate marijuana to be used for the patients own medicinal purposes. MMAD is believed to have acquired one-half acres on South Liberty in the City limits to establish this co-op marijuana farm.

Both City departments have been dealing with the variety of complaints coming in concerning everything from the odor coming from the business location, zoning restrictions (or lack thereof) for the business, smoking marijuana in public places, loitering, patrons being under the influence, a burglary of the business, etc. MMAD claims to have over 200 hundred patients "signed up" with them which equates to a large amount of medicinal marijuana growing in and going out of the "business."

The City of Visalia is not the first, nor will it be the last, to have to deal with the issues presented by the Compassionate Use Act. Implementing an ordinance to regulate the cultivation, possession, use and distribution of medicinal marijuana does not condone the use of marijuana. However, it does recognize that the People of the State of California by passing Proposition 215, and the California Legislature by passing SB 420, have provided for the medical use of marijuana. And with that in mind, the City of Visalia wishes to insure that the adverse impacts from the medical use of marijuana are minimized within its city limits.

Other cities in the Valley have adopted ordinances regulating Medical Marijuana Dispensaries, such as the City of Fresno on October 26, 2004; the City of Clovis on December 6, 2004; the City of Fowler on December 7, 2004; and the City of Selma on March 7, 2005. Beyond those boundaries, the City of Jackson imposed operational and zoning restrictions on Medical Cannabis Dispensaries on May 24, 2004, as did the City of Roseville. The City of Elk Grove established Medical Cannabis Dispensaries as a conditional permitted use on April 7, 2004.

The first step is to adopt an emergency/urgency ordinance for the regulation of the dispensaries within the city. Without a city ordinance in place, medical marijuana dispensaries could operate within the City without restriction.

The second step is to adopt a permanent ordinance regulating the cultivation, possession, use and distribution of medicinal marijuana. The permanent ordinance would be more expansive and provide the needed restrictions on the activities otherwise made legal by the Compassionate Use Act of 1996.

RECOMMENDATION

It is our recommendation that the City pass an emergency/urgency ordinance to regulate the distribution of medicinal marijuana through dispensaries. It is further our recommendation that the City adopt a permanent ordinance pertaining to the cultivation, possession, use and distribution of medicinal marijuana within the City's limits.

Request is hereby made that Council authorize the City Attorney's Office to prepare and submit an emergency/urgency ordinance to limit/regulate marijuana dispensaries and direct the City staff and City Attorney's Office to consider, study, and draft a permanent ordinance for Council's consideration that would regulate the cultivation, possession, use and distribution of medicinal marijuana within the City's limits.

Department Recommendation and Summary:

Executive Summary:

The purpose of this work session is to present Council with an update of the proposed service by Scenic Airlines and an overview of the goal of the California Airports Coalition (CAAC) to acquire regional air service for the smaller markets in California. Specifically, Staff recommends that Council:

- 1) Direct staff to pursue a joint grant to provide regional air service for smaller California markets; and,
- 2) If successful, set-aside \$5,000 from the General Fund as non-airport, matching funds for a potential grant from the FAA.

Background:

On April 8, 2005, the City of Visalia, with the prior approval of Council, submitted a comment letter to the Department of Transportation (DOT) supporting the proposal submitted by Scenic Airlines and asking the DOT to select Scenic Airlines as the Essential Air Service provider for the Visalia Municipal Airport.

Scenic Airlines has proposed to provide ten (10) round trips per week from Visalia to the North Las Vegas Airport. Scenic maintains a new Terminal facility at the North Las Vegas airport and offers free shuttle service to all area hotels. Additionally, Scenic offers free transfer shuttles to the Las Vegas International Airport for those travelers seeking to take advantage of the numerous destinations out of Las Vegas.

Scenic Airlines began business as a tour operator and still operates several tours per day to the Grand Canyon, Hoover Dam and other locations throughout Nevada. The air service provided

to Visalia will also present great opportunities for the local tourism community to tie into the diverse group of people that visit Las Vegas.

In addition to the new service to be offered to Las Vegas, staff has been working with other airports in the state in an effort to develop regional air service throughout the state. Fifteen (15) airports have collaborated and are moving forward with efforts to further broad program to address air service needs in smaller underserved communities throughout California.

As part of their efforts, the California Airports Coalition (CAAC) is applying for approximately \$300,000 in Small Community Grant Funding in this year to perform a market and feasibility study for many airports in the state. Under the funding program, one entity has to be the legal sponsor for the grant agreement. Barry Rondinella, Airport Director for the Stockton Airport is the current unofficial leader of the CAAC and as such, the San Joaquin Council of Governments has agreed to be the legal sponsor for this first phase of the program.

This grant application is unique for several reasons. First, it addresses intrastate as well as interstate air service problems that are distinct to California. Second, the genesis for the plan was the CAAC, 15 airports serving smaller communities throughout the state. Last, the approach is "big picture". The plan is to create a small, successful air service system within the state that can, in the future, expand to include additional small underserved communities within California. This creative first step has the potential to grow into a program with far reaching benefits for California.

The CAAC has hired Mike Boggs, of Mead & Hunt, a well-known Air Service Development consultant, to prepare this years application for grant funding at a cost of \$2,000 per community. The funding to pay the consultant was paid out of the Airport Enterprise Fund. Additionally, the consultant has requested that each partner secure \$5,000 in required local non-airport matching funds to serve as the required match for the Small Community Air Service Development Program (SCASDP). As a part of this work session, staff is also asking Council to appropriate \$5,000 out of the City's General Fund to serve as the required local match for the grant.

Prior Council/Board Actions:

June 16, 2003 - Council adopted Resolution 2003-79 authorized staff to submit an application for the Small Community Air Service Development Grant.

April 4, 2005 – Council authorized the formal recognition of the Air Service Sub-committee and authorized the committee to submit comments to the DOT conveying the Community's position on the proposals for air service.

Department Recommendation and Summary:

Staff recommends that the City Council authorize the purchasing Department to request proposals from qualified firms to update the Strom Sewer Master Plan.

The last Storm Sewer Master plan was completed by Boyle Engineering Corporation in September 1994. The 1994 Master Plan brought the Storm Sewer Master Plan (SSMP) into compliance with the 1991 Land Use Element (LUE). The SSMP studied the drainage system of the City out to the year 2020. The plan proposed ponding basins, park ponds, trunk lines, and direct discharges into creek and irrigation channels. As land has developed within the City since the adoption of the SSMP, changes were made to SSMP (location of ponds, deletion of direct discharges, type of ponds, ect.) to better serve the City and to address changes in the laws in regards to storm water discharge.

With the changes that have occurred over the last 11 years there is a need to update the SSMP. The update will need to address the growth of the city, the locations of the existing ponding basins, new National Pollution Discharge Elimination System (NPDES) laws, groundwater recharge, and a fee system to accomplish the recommendations. The request for proposals also includes the following:

- Review of existing SSMP
- Existing system analysis and recommendations for system improvements
- Strategies and recommendations for incorporating parks and recreation facilities into storm water facilities.
- CIP financing of proposed improvements
- Groundwater recharge
- Storm Sewer management system
- California Environmental Quality Act (CEQA) documentation

Recommendation:

RESOLUTION NO. 2005-54

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF VISALIA REQUESTING AND CONSENTING TO CONSOLIDATION OF ELECTIONS; AND SETTING SPECIFICATIONS OF THE ELECTION ORDER

WHEREAS, the City Council has ordered a Municipal Election to be held on Tuesday, November 8, 2005, to fill certain municipal offices; and

WHEREAS, other elections may be held in whole or in part of the territory of the City and it is to the advantage of the City to consolidate pursuant to Elections Code Section 10400; and

WHEREAS, Elections Code Section 10242 provides that the governing body shall determine the hours of opening and closing the polls; and

WHEREAS, Elections Code Section 10002 requires the City to reimburse the County in full for the services performed upon presentation of a bill to the City by the County Elections Official; and

The Civic Center Master Plan will provide a comprehensive strategy for urban design, facility planning and financing. The scope of services is organized into three sections:

- 1. Facility programming whereby the consultants will evaluate space needs, logistics and long-term development;

Visalia Civic Center Master Plan

PLANNING AREA

The planning area for the Civic Center includes the 40 acres acquired from UPRR bounded by Mill Creek, Ben Maddox and Goshen. In addition to this land, the team will consider asset management opportunities for existing city-owned property currently being used for parking, public safety, community development, and city hall uses.

MASTER PLANNING TEAM

The Master Planning team is comprised of seasoned architects, programmers, and economic consultants that have associated on other facility and urban revitalization projects. The team includes:

- Bruce Race, FAIA, AICP, RACESTUDIO, Urban Design
- Paul Heath, Business Place Strategies, Program and Facilities
- Andy Plescia, A. Plescia Company, Real Estate
- Anne Simpson, Anne Simpson Associates, Financial Modeling

This multi-disciplinary approach is intended to augment the City's own professional staff to provide a comprehensive design, programming and funding strategy.

SCOPE OF SERVICES

The Civic Center Master Plan is to provide a comprehensive strategy for urban design, facility planning and financing. The scope of services is organized into three phases where facility programming, site planning and financing and real estate strategies are assessed, tested and then integrated into a master plan.

Each phase will be organized around a consultant team on-site charrette. There are three charrette-style sessions of three days each. These are intended to provide an intensive and more compact process that emphasizes client interaction and community participation. At the end of each charrette, the team will present and discuss the results with the Civic Center Subcommittee.

Phase 1: Assessment

The first phase involves assessing the program, design and funding opportunities and needs for the civic center. The phase will include a kick-off meeting with city staff to determine data collection needs and review the schedule.

Department Recommendation:

That the Visalia City Council authorize the City Manager to execute a renewed professional services agreement with Jefferson Government Relations (Washington, D.C.) in the amount of \$60,000 annually for continuing federal legislative advocacy services through March 2006. Staff also recommends that the City distribute Requests for Proposals for Federal Lobbying services in 2006. The City has contracted with Jefferson Government Relations since 2000. Per City Purchasing Policy, "contracts for services shall not usually cover a period of more than one (1) year, although longer periods may be approved. Unless exempted from competitive bidding procedures, contracts for goods and service should not extend, either by original contract or by extension, beyond five (5) years unless competitive bids/proposals have been sought or approval is obtained from the Purchasing Agent."

Summary:

The City has been working closely with this legislative advocacy firm on a wide range of issues affecting the City. The firm has proved to be extremely valuable in providing an effective communication link between the City of Visalia and legislators and officials in Washington, D.C., and had greatly enhanced the City's effectiveness in the legislative process.

The staff of Jefferson Government Relations – specifically Art Roberts and Daniel Sheehan – have continued to demonstrate their ability to effectively monitor legislative activity in Washington and to proactively communicate these issues to the City of Visalia. They have also demonstrated their ability to establish effective working relationships with individual legislators, staff members, and officials from various federal agencies, and to facilitate the City's interaction with these individuals. It should be noted that Art Roberts retired this year and is no longer with the firm.

- JGR guided the City's earmark requests through the entire appropriations process, including close coordination with City officials, completion of required forms and documentation, drafting of letters and testimony in support of City projects by Visalia's congressional delegation, lobbying of congressional appropriators and their staffs, close monitoring of congressional action, and interventions with congressional members and staffs to ensure timely follow-on contacts with key appropriators.
- Last year, JGR helped secure for the City \$500,000 for its Bus Operations and Maintenance Facility and bus fleet conversion to natural-gas buses. That amount is a full one-quarter of the total amount Los Angeles secured for its buses. This funding follows on the \$1 million JGR helped in fiscal year 2004 for the Bus Operations and Maintenance Facility. In a time of constricted federal budgets, effective representation of the kind provided by JGR is critical to the City's ultimate success in appropriations earmark requests.

JGR secured \$250,000 for the project in Transportation-Treasury Appropriations (P.L.108-447). That amount followed \$1 million secured for the project in fiscal year 2004 (P.L.108-199). The City is seeking \$2.03 million in both transportation authorization (TEA-21) and fiscal year 2006 appropriations to complete federal participation in this project. According to Transit Director Monty Cox, the project is expected to commence this summer. JGR also secured \$250,000 in last year's Transportation-Treasury Appropriations for Visalia's conversion of its bus fleet to natural gas vehicles.

- West Acequia Parking Structure In 2004, JGR requested as a backstop for the City's pending \$3.94 million federal grant from the Economic Development Administration (EDA) in the Department of Commerce. With the grant pending, Congress did not earmark funds for this project in the VA-HUD Appropriations bill (Economic Development Initiative account). EDA formally invited the City to apply for the grant last year, but could not award the grant until federal funds were available. The grant was awarded on February 1, 2005.
- Mill Creek Greenway Trail Last sought in 2003, this \$1 million request was for the creation of a green space in the city core that would spur economic activity, enhance surrounding property values, and provide Visalia residents with a respite from city bustle. Not

requested last year in lieu of other projects more in line with Representative Devin Nunes's interests in projects affecting the flow of commerce and people in the City.

Ben Maddox Way Bridge

Throughout 2003-2004, sought \$6.2 million in transportation law (TEA-21) reauthorization for the Ben Maddox Way bridge improvement. The House approved \$2 million for the project when it passed H.R. 3550 in April 2004. House-Senate negotiations failed later that year and H.R. 3550 fell when the 108th Congress dissolved in December. Last month, the House again approved \$2 million for the project. The Senate is expected to pass its bill in May. A final bill could be enacted by the July 4 recess period.

Transportation Reauthorization:

JGR coordinated closely with the City officials and its congressional delegation to put forward Visalia's road and transit projects for congressional authorization. Although Congress last year failed to complete action on the reauthorization of the Transportation Equity Act for the 21st Century (or TEA-21), JGR did succeed in helping the House authorize \$2 million for the Ben Maddox Way Bridge project. With the new 109th Congress, JGR earlier this year worked closely with Visalia's road and transit professionals to provide Congress with compelling justifications for the City's initiatives. As a direct result of these efforts, the House once again authorized \$2 million for the Ben Maddox project when it approved its reauthorization bill last month. The Senate is expected to move its bill later this month or in early May. Program authority expires on May 31. If a House-Senate conference cannot produce a compromise bill by that time, Congress will have to pass yet another short-term extension of TEA-21 -- the eighth since the law expired in September 2003.

In support of the City's projects, JGR has completed and submitted in a timely fashion all required documentation, drafted letters and testimony of support for the Visalia congressional delegation, lobbied key congressional authorizers and their staffs, all the while cooperating closely with the Visalia congressional delegation. JGR will also monitor House-Senate negotiations carefully so to better ensure Visalia's projects are included in the final bill.

Political Participation -- JGR once again participated in a Representative Devin Nunes fundraising event in Washington last month. JGR is proud to support Visalia's congressman and looks forward to a long-lasting relationship with him and his staff.

2005 WORK PROGRAM

Transportation Reauthorization

Congress is seeking to approve a six-year reauthorization of the nation's surface transportation law, the Transportation Equity Act for the 21st Century (TEA-21). That law expired in September 2003 and has been extended through a series of short-term extensions, with the last of which set to expire May 31, 2005. In addition to authorizing program authority for government transportation programs, the reauthorization bill also earmarks federal dollars for specific projects. The City has put forward the following projects to be included in the legislation.

- Ben Maddox Way Bridge Improvement \$6.2 million
- Bus Operations and Maintenance Facility \$2.03 million
- Caldwell Avenue Widening \$1 million
- Plaza Drive Widening \$9 million

The House passed its version of the bill last month (H.R. 3) and approved \$2 million for the Ben Maddox Way Bridge improvement project. The Senate is expected to pass its bill early next month. The House-Senate conference will then meet to hammer out a final compromise bill.

Fiscal Year 2006 Appropriations

Each year, Congress must pass its yearly federal spending bills. Visalia has been very successful in securing federal earmarks in these bills over the last four years. (\$4 million since 2001.) This year, Visalia has requested the following federal earmarks for its projects in the fiscal year 2006 Transportation-Treasury-Housing Appropriations bill.

• Visalia Bus Operations and Maintenance Facility--\$2.03 million Federal Transit Administration; Bus and Bus Facilities Account

This funding will help construct and outfit the City's planned 31,500 square-foot bus operations facility.

• Visalia Bus Fleet Conversion--\$2.4 million Federal Transit Administration; Bus and Bus Facilities Account

This request will allow the Visalia to continue to convert its bus fleet from diesel to compressed natural gas (CNG), a much cleaner alternative fuel.

• Visalia Shuttle Bus Purchase--\$2.3 million Federal Transit Administration; Bus and Bus Facilities Account

These funds will help the City purchase several natural gas buses to shuttle visitors from downtown Visalia to the Sequoia and Kings Canyon National Parks.

• Visalia Visitors Center--\$2.4 million

Housing and Urban Development; Economic Development Initiatives Account

This appropriation will help the City build a new visitors center in downtown

Visalia and help it realize its plans to serve as the gateway community for the Sequoia and Kings Canyon National Parks.

General Representation

Jefferson Government Group will also continue to provide general representational services to the City as needs and issues arise. Chief among those issues include matters pertaining to the Visalia Municipal Airport and its ongoing efforts to secure and sustain regularly scheduled commercial service to and from good airline hub markets. JGR will also coordinate closely with the City in its efforts to serve as a gateway community to the Sequoia and Kings Canyon National Parks.

History:

2000-The City engaged the services of Jefferson Government Relations. The City, in need of a modern downtown transit center and bus operations and maintenance facility, asked the Jefferson group to use its expertise, access and abilities to secure federal funding. Working with Visalia officials and federal legislators the Jefferson group was able to secure federal support for both the transit center and the bus facility.

2001- Art Roberts and Daniel Sheehan, along with other members of their firm, were instrumental in securing \$2.5 million in the Fiscal Year 2002 Transportation Appropriations Bill (Public Law 107-87) for the newly completed City of Visalia Transit Center. Also in 2001, the Jefferson group coordinated with Representative Cal Dooley and his staff winning \$3 million for the Cross Valley Rail Corridor Project.

2003-The Jefferson group was able to gain support for \$1 million earmark in the Fiscal Year 2004 Transportation-Treasury Appropriation Bill (H.R. 2898). This measure was approved as part of the omnibus appropriations legislation cleared by Congress for the President Bush's signature on January 22, 2004.

Staff believes that the performance of this firm, and the tangible results of their efforts, justifies the one (1) year renewal of the current agreement. The City has benefited financially and politically from the efforts put forth by Jefferson Government Relations firm on behalf of the City of Visalia. The expense of this contract is an investment for the City of Visalia and an investment in the community.

Department Recommendation and Summary:

It is recommended that the City of Visalia enter into a contract with the Visalia Chamber of Commerce for the lease of the building at 720 W. Mineral King for \$825/month, on a month-to-month contract.

The City entered into a contract with the Chamber in August, 1985 for a five year lease on the building on W. Mineral King, with three five year extensions. The final extension was approved in June, 2000. The Chamber has purchase property for a new building on Oak Street, and will begin construction shortly; however, they have requested to stay in their current location until construction is complete, sometime within the next year. Therefore, staff is recommending that a lease be extended on a month-to-month basis, with a 30-day cancellation clause.

It is recommended that the Chamber pay \$825/month rent during the term of this lease. Previously, the rent was \$1/year, and the Chamber paid \$825 to reimburse the City for remodeling expenses. The lease and the extension specifically provided for a renegotiation of the rent for any extended term of the lease, although that option was never pursued. In light of the short term nature of this lease, and in an effort to assist the Chamber in their efforts to transition into the new sight in the northeast downtown. This is an area that the City is interested in seeing redevelop, staff is recommending that the rent be \$825/month, with the income being slated for the Civic Center Development account. This will provide some compensation to the City for the space, and still allow the Chamber to maintain a consistent budget during this transition period.

The Chamber does use the third-party option and leases space to the Visalia Economic Development Corporation, the Visalia Tourism Bureau, the Sequoia Fund, and the Small Business Development Corporation.

Department Recommendation and Summary: It is recommended that the City Council approve a contract extension with the Visalia Chamber of Commerce for management of the Tourism Bureau for the calendar quarter ending June 30, 2005, at a cost of \$31,300, which is consistent with the amount budgeted.

When the City renewed the Tourism Bureau contract last year with the Chamber, it was for a partial year because the Council had formed the Visitor Task Force and anticipated that based on the Task Force's review, changes would be implemented by the end of the third quarter. Because the Council was interested in seeing the recommendations of the Task Force implemented as quickly as possible, the contract was not issued for the full year, but only until the end of March, 2005, to allow for flexibility in making changes.

However, the Task Force's review and recommendation has been delayed. Due to a major staffing change at the Tourism Bureau, the Task Force's meeting schedule was extended. The Task Force held a 4-hour work session last Tuesday, April 12 and significant progress was made on the recommendation. It is anticipated a report will come before the Council in May.

Meanwhile, significant process has been made at the Tourism Bureau. The new Manager, Kristi Johnson, an experienced Tourism Bureau Manager, is reviewing and critiquing the past/current efforts and refining the program so it is more effective, more efficient and will ultimately result in more tourism in Visalia. As indicated in the attached report, she readily realizes the importance of attracting people via the Internet. She has also set short term (3-month goals) for the remainder of the contract, and long-term goals that include implementing performance-reporting standards based on the International and/or State Visitor and Convention Bureau Association's recommendations.

Department Recommendation and Summary: It is recommended that the Visalia City Council approve a two-year contract with Downtown Visalians for security and cleaning services at the parking structure, and periodic cleaning of the surface of the Garden Street Plaza as needed at the prices indicated.

The Downtown Visalians has been responsible for providing the security services for the Acequia Parking Structure since 1999. Because the organization also contracts for security for the downtown, it is believed that having the same firm in the parking structure improves communication and back up support amongst the security officers, and results in a more comprehensive approach to security in the downtown area. The Downtown Security Officers are required to have a higher level of training, including Penal Code 832 training, police codes and customer contact/service. In addition, they must provide back up for break and meal coverage. There have been few, if any complaints and the arrangement appears to be working well.

The contract for security at the parking structure calls for one security officer during the hours of 5 p.m. to 2 a.m., seven days a week, including all holidays. The price is set for the full two years at \$4,588/month, which is a 6.4% increase (\$276/month or \$1.02 an hour) over the current one-year contract. This includes an overhead cost of 10%, which includes on-site and off-hour observation, report follow up, monthly committee meetings and at-least quarterly reports to the City. Given the amount of time City staff must spend on oversight in high-use facilities where there is no oversight, this charge seems reasonable.

While the proposed cost is somewhat higher than some of current security contracts, it is in keeping with the costs given the higher level of service, and the management oversight. The Transit Center and Waste Water Treatment Plant currently pay \$11.50/hour for basic service. The Airport pays \$15.50/hour for a basic guard with a vehicle. The increased price at the

parking structure would be \$16.99/hr, including the overhead cost, or about \$15.50/hr for full coverage with higher trained security officers.

A two-year contract is being recommended because the new parking structure should be operational and the City can determine at that time how to best handle security at both facilities.

The Downtown Visalians also steam cleans the stairs wells of the parking structure. This service is performed weekly, for a total cost of \$400 a month, which includes the equipment and personnel for the service. No cost increase was requested.

It is also recommended that the City have the ability to request the Downtown Visalians to clean the surface of the Garden Street Plaza as needed. The Plaza has become a popular gathering place and the surface has become soiled. The Downtown Visalians have a "wand" attachment for their steam cleaning unit that can clean much of the grim. The "wand" is a softer approach that traditional steam cleaning, which provides less wear-and-tear on the brick surface. David Jacobs, Assistant Community Development and Public Works Director, has approved this process as one that will not negatively affect the base into which the bricks and pavers are set. Downtown Visalians and the City will continue to explore other cleaning options that could be less time-consuming, and/or less costly, and/or a more effective approach to cleaning the bricks and pavers. While this research continues, staff would like the authorization to use this cleaning method as needed. The cost would be \$195 per cleaning.

There are adequate funds available to cover this contract in both the 2004/05 and the 2005/06 budgets.

Recommendation and Summary:

City Staff is recommending City Council authorize the City Manager to execute the attached agreement between Tulare County and the City of Visalia to share the cost of design and construction of traffic signals at the intersections of Woodland Street and Mineral King Avenue and Woodland Street and Burrel Avenue to facilitate the opening of Woodland Street at Mineral King Avenue. The City Attorney's office and County Counsel have both reviewed and approved this agreement.

The County of Tulare and the City of Visalia desire to reopen Woodland Street between Main Street and Mineral King Avenue. Traffic signals will be installed at the intersections of Main Street and Woodland Street and at Burrel Avenue and Woodland Street. The existing traffic signal at the intersection of Mineral King Avenue and Woodland Street will be modified to function with the re-opening of Woodland Street to the north. The opening of Woodland Street between Mineral King Avenue and Main Street will provide better traffic circulation for the County Civic Center, COS, and the neighborhoods in this area.

The County of Tulare will deed to the City of Visalia Woodland Street between Mineral King Avenue and Main Street as well as Burrel Avenue between Woodland Street and Mooney Boulevard. The County of Tulare will maintain Burrel Avenue west of Woodland Street as a private roadway servicing the County's facilities. The County will share the cost of the modification to the existing traffic signal at Woodland Street and Mineral King Avenue and the design and construction of the new traffic signal at Woodland Street and Burrel Avenue. The new traffic signal at the intersection of Woodland Street and Main Street will be the sole responsibility of the City of Visalia.

A contract is being finalized with Provost & Pritchard Engineering Group, Inc. of Visalia for the plans and specifications needed for the construction of the traffic signals and the related street improvements. The City's share of the cost for these services is \$25,850.00. The estimated construction cost of the signal improvements at Woodland Street and Mineral King and Woodland Street and Burrel Avenue is \$450,000. Both the City and the County will pay half of this expense (\$250,000). The estimated cost of installing the signal at Main Street and Woodland Street is \$175,000. The City will pay all of this expense.



Staff recommends that City Council approve the recordation of the final map for Maddox @ Caldwell 5, Phase 4 containing 16 Single Family Lots. All bonds, cash payments, subdivision agreement and final map are in the possession of the City as follows: 1) An executed subdivision agreement; 2) Faithful Performance Bond in the amount of \$5,313.30 and Labor and Material Bond in the amount of \$22,966.50; 3) cash payment of \$21,668.08 distributed to various accounts; and 4) Final Map.

The Faithful Performance Bond covers the construction costs of the uncompleted public improvements noted in the subdivision agreement, the Labor and Material Bond covers the salaries and benefits as well as the materials supplied to install the required public improvements. As required by the Subdivision Ordinance, the Faithful Performance Bond should cover 100% of the cost of the public improvements. The Labor and Material Bond is valued at 50% of the Faithful Performance Bond. However, since 90% of the public improvements is already in place at the time of preparing the subdivision agreement. The developer submitted a Faithful Performance Bond that covers the construction costs for the public improvements that were not in place at the time of preparing the subdivision agreement. The Labor and Material Bond covers 50% of the initial costs of the public improvements. The Faithful Performance Bond can be reduced to 10% of the public construction costs after the Notice of Completion is recorded. The Faithful Performance Bond is held for one year after the recording and acts as a warranty for the public improvements installed per the subdivision agreement. The cash payment covers Development Impact Fees such as storm water acquisition, waterways, sewer front foot fees and any outstanding plan check and inspection

fees. The plan check and inspection fees are estimated at the beginning of the Final Map process and are not confirmed until the subdivision agreement is finalized. Differences are due in cash at the time of City Council approval of the Final Map.

Landscape & Lighting

Staff recommends that the City Council: adopt Resolution No. 05-57 Initiating Proceedings for Formation of Assessment District No. 05-10, Maddox @ Caldwell 5, ; adopt the Engineer's Report as submitted; and adopt Resolution No. 05-58 confirming the Engineer's Report, ordering the improvements and levying the annual assessments.

The City of Visalia has been allowing the developers of subdivisions to form assessment districts under the Landscape and Lighting Act of 1972, and now under Proposition 218, in lieu of using homeowners associations for the maintenance of common features such as landscaping, irrigation systems, street lights and trees on local streets. The maintenance of these improvements is a special benefit to the development and enhances the land values to the individual property owners in the district.

The Landscape and Lighting Act allows for the use of summary proceedings when all the affected property owners have given their written consent. This process waives the requirement for a public hearing since the owners of this development have given their written consent to form this district. This development was done in several phases as planned.

The first three phases of this tentative subdivision map were recorded in July 2003. However, a Landscape and Lighting District was not formed at the time of recordation. Fortunately, these final maps and the title reports for all the sold Lots indicated that this subdivision is subject to The Landscape and Lighting Act of 1972, and the new owners are obligated to participate in such a district. This will allow the City of Visalia to form a Landscape and Lighting District without having to hold an election among the new owners.

Prior Council/Board Actions: The City has been allowing the use of the Landscape and Lighting Act of 1972 for maintaining common area features that are a special benefit and enhance the subdivision.

Committee/Commission Review and Actions: The tentative subdivision map for the Maddox @ Caldwell 5 subdivision was approved by the Planning Commission on March 11, 2002. The tentative map would have expired on March 11, 2004. The Planning Commission passed and adopted Resolution NO. 2002-33 approving Conditional Use Permit No. 2002-09. The CUP became effective on March 19, 2002, and would have initially expired concurrently with Maddox @ Caldwell 5 Tentative Map on March 11, 2004. A maximum time extension of three years was requested on February 10, 2004, so the tentative subdivision map would expire on March 11, 2007.

Assessment Diagram Assessment District No. 05-10 City of Visalia, Tulare County, California



Landscape Location Diagram Maddox @ Caldwell 5



General Description

This Assessment District (District) is locate West of Ben Maddox Way and north of Monte Verde Avenue. Exhibit "A" is a map of Assessment District 05-10. This District includes the maintenance of turf, shrubs, street lights, trees, and any other applicable equipment or improvements, maintaining the integrity of the wall, irrigation system and seeing that any acts of vandalism (graffiti, theft or damage) are mitigated in a timely fashion.

Determination of Benefit

The purpose of landscaping is to provide an aesthetic impression for the area. The lighting is to provide safety and visual impressions for the area. The wall provides security, aesthetics, and sound suppression. The maintenance of the landscaping, lighting, and wall is vital for the protection of both economic and humanistic values of the development. The City Council has determined that in order to preserve the values incorporated within developments and to concurrently have an adequate funding source for maintenance of the landscaping, lighting, walls and all internal local streets should be included in a maintenance district to ensure satisfactory levels of maintenance.

Method of Apportionment

In order to provide an equitable assessment to all owners within the District, the following method of apportionment has been used. All lots in the District benefit equally including lots not adjacent to the landscaping, wall and lights. The lots not adjacent to the landscaping, wall and lights benefit by the uniform maintenance and appearance of the District.

Estimated Costs

The District includes not only the maintenance of the turf, the shrubs, trees and street lights, but maintaining the integrity of the wall, irrigation system and seeing that any acts of vandalism (graffiti, theft or damage) are mitigated in a timely fashion. The total number of lots within the district is 74.

This assessment district shall be subject to a maximum annual assessment (A_{max}) for any given year "n" based on the following formula:

 for any given year "n" = (\$14,022.37) (1.05)

where "n" equals the age of the assessment district with year one (1) being the year that the assessment district was formed;

The actual annual assessment for any given year will be based on the estimated cost of maintaining the improvements in the district plus any prior years' deficit and less any carryover. In no case shall the annual assessment be greater than maximum annual assessment as calculated by the formula above. The maximum annual increase for any given year shall be limited to 10% as long as the annual assessment does not exceed the maximum annual assessment as calculated by the formula above.

The reserve fund shall be maintained at a level of 10% of the estimated annual cost of maintaining the improvements in the district. If the reserve fund falls below 10%, then an amount will be calculated to restore the reserve fund to a level of 10%. This amount will be recognized as a deficit and applied to next year's annual assessment.

Department Recommendation and Summary: Hold a protest hearing regarding the formation of Open Space District No. 87, Four Creek Estates II. If less than 50% of property owners protest in writing, adopt a resolution forming the Open Space District. Resolution No. 2005-59 required.

Discussion: In 1988 City Council adopted an update to the original 1979 Northeast Area Specific Plan. The Specific Plan lays the groundwork for required public improvements specific to the Northeast area and the maintenance thereof. The improvements consist of sidewalks/bike paths, center medians, frontage landscaping and decorative block walls. Policies 5 and 6 of Goal 5 of the Specific Plan speak to the issue of formation of maintenance districts and collection of fees for all development in the Northeast Plan area.

The Planning Commission has approved the Tentative Map for Four Creeks Estates II, located on Buena Vista Avenue between Burke Street and Ben Maddox Way. This map will create 86 single family lots. One of the conditions of the Tentative Map requires the formation of an open space maintenance district for the maintenance of amenities within the Northeast Specific Plan area. As noted above, the Specific Plan requires open space maintenance districts to be established for the purpose of maintaining amenities such as landscaping along public streets, walkways, crosswalks, parking areas, drainage facilities, parkways, lighting, and sprinkler systems.

At the Council meeting on April 4, 2005, a resolution of intention to form Open Space District No. 87, Four Creeks Estate II was passed; this resolution set the date for a protest hearing to allow property owners and the owners of residential units within the proposed district to oppose its formation. Opposition must be in the form of a written protest.

Greg Dais 713-4164 Andrew Benelli 713-4340 Once a protest hearing has been held, and if no more than 50% of property owners protests in writing, Council may pass a resolution to form the open space district. Formation of this district was a requirement of the Tentative Map in order to provide for maintenance of the improvements and landscaping within the Northeast Master Plan Area. The property owner(s) will be assessed \$44.28 per year which will be collected either by billing by the City of Visalia or collected with property taxes by the County of Tulare. The affected area is currently owned by one owner (West Star Construction, Inc.) who has consented to the formation of the district. Although consent has been provided, state law requires that the protest hearing be held prior to the formation of the district.

Prior Council/Board Actions: On April 4, 2005 Council approved a resolution of intention to form Open Space District No. 87, Four Creeks Estates II.

Committee/Commission Review and Actions: Planning Commission approved Four Creeks Estate II on April 26, 2004.



Department Recommendation and Summary: Staff recommends that Council authorize the City Manager to enter into contract with Deventec, Inc., Energy Management Solutions, for the installation of a photovoltaic energy generation system mounted on a parking shade structure at the Visalia Airport for a net cost of one hundred seventy five thousand and five hundred dollars (\$175,500). Deventec will apply for a California Energy Commission rebate of \$84,000 and it is customary that as long as funds are available and a licensed contractor is employed then the application will be granted. The City will not need to front the anticipated rebate. The contract will have a provision whereby it becomes null if the rebate is not granted.

Discussion

Six proposals were received in response to the City RFP to offer the best solution including photovoltaic panels to reducing the energy dependence at the Visalia Airport. The RFP requested a 30 kilowatt photovoltaic energy system either on Hangar C, the Pilot's Lounge roof or a freestanding parking shade structure. Proposers were also given the opportunity to offer an alternative creative solution. The maximum 30 kilowatt system was designated after the rebates for systems over 30 kilowatts offered by Southern California Edison were no longer available.

A review Committee was formed including Chriss Helgeson, a building inspector with extensive experience in photovoltaics resulting from working at SCE, and Sharon Sheltzer, Project Manager, who also has experience in this field, to review the proposals. The top three qualified firms were selected. After they were designated as the most qualified their cost proposals were opened in the presence of an expanded committee that included Chriss, Sharon, Mario Cifuentez, Airport Manager, and Gus Aiello, Finance Manager. In alphabetical order the proposals were:

<u>Analys</u>is

The proposers were requested to analyze the options of installing photovoltaic panels on either Hanger "C", the Pilot's Lounge roof, or a parking shade structure/alternative creative solution.

Parking Shade Structure

A similar amount of money would need to be spent to bore under the asphalt to provide electrical conduit from the Pilot's Lounge to Hanger "C" as would be spent for the shade structure which provides a tangible benefit. The shade structure can be connected to the airport with a much shorter conduit via trenching. Mario Cifuentez believes that it would be a valuable addition to the airport to have a shaded parking area, and the energy system in a more visible location to the public, to highlight the City's commitment to energy efficiency.

Hanger "C"

There is some question if the 30 year old hanger roof is in good enough condition and has the structural integrity to support the installation. An engineer would have to be hired to make this determination. Boring for electrical conduit from the Pilot's Lounge to the hanger would be expensive and disruptive.

Pilot's Lounge roof

The Pilot's Lounge roof is covered with equipment and was determined by most proposers to be unsuitable for the installation.

The Committee believed that more value would be derived from this installation if a parking shade structure (and possibly a solar awning on the south side of the Pilot's Lounge) were installed as a means of supporting the photovoltaic installation. The two companies designated as qualified that proposed a parking shade structure mounting system were Deventec and National Builder's Supply. Deventec also offered the alternative to provide half the PV panels on a solar awning that would also reduce the heat build-up in the lounge, and half the PV panels on a smaller parking shade structure. This alternative does not increase Deventec's proposal price, and they indicate that if the hybrid is chosen it may cost less than the larger parking structure.

The Proposal Review Committee recommends the Deventec proposal because the shade structure offered by them was more practical. The support poles of the cantilevered structure are out of the way of parking cars, and more aesthetically pleasing. Please review the attached photo and drawing of the proposed parking structure system designated as "A". The National Builders Supply shade structure has poles at each corner that would interfere with easy parking and it might be more appropriate in a less visible location. Please review the attached photo designated as "B. The Deventec proposal would provide Sharp modules (the most efficient on the market) and multiple invertors and is designed for a capacity just under 30 kilowatts which will provide approximately 62% of the electricity normally provided by Southern California Edison. Staff would like to pursue the option of the combination parking/awning proposal

Financial Analysis

The payback period is the amount of time that it takes to recoup the original installation expenditure by totaling the savings on the electric bill until the savings exceeds the expenditure. After that time the electricity generated by the system is free with the exception of historically low maintenance costs.

Deventec calculated the payback period for the 30 kW photovoltaic installation to be approximately 13 years. Please review the Deventec Chart. They believe this is a conservative estimate because although it includes the SCE historical annual inflation rate (8% for small commercial) it does not include the expected inflationary cost of electricity and does not incorporate the possibility of leveraging a time-of-use electricity meter. Deventec projects that the break-even period could possibly be shortened to 10 years.

City staff performed an analysis using California Public Utilities Commission prices for electricity, which are an assembly of historic prices from many providers and last years cost per kilowatt of 0.1441. This table inflationary rate is 6.5% and the City calculations ascertained a payback period between 13 and 14 years, corroborating the Deventec calculation.

Finance provided an analysis of the projected return on investment. Assuming a 25 year life expectancy for the PV panels which is guaranteed by warranty, an 8% per year rise in electricity costs and no additional maintenance costs, the return on investment would be 9.5%. This number would most likely be adjusted by two factors: the inverter's life span is 20 years (today's cost to replace is \$28,000) and will have to be replaced before the PV panels, and the PV panels historically continue to operate beyond their warranty time. The continued operation after the 20th year would offset the cost of the new inverters in one year's time.
