Department Recommendation and Summary: Staff recommends that the City Council award the contract to construct a 1,740 foot asphalt and concrete path along the south side of Mill Creek between W. Main and Demaree to Lockwood General Engineering Inc, for the bid price of \$54,733.00.

On October 27, 2005 the City opened three (3) bids. The results of the bid opening are as follows:

Lockwood General Engineering
 Lee's Paving
 Sierra Range Construction
 54,733.00
 56,492.00
 59,575.86

There is a \$4,843 difference between the high and low bids which represents a 9% spread and indicates the bids are competitive. The bids are higher than the engineer's estimate because access to the project will be from Demaree and the paving operation will require trucks to back down the creek levee to the eastern end and then pave in a westerly direction for the length of the project. This will be very labor intensive to back equipment into the job site one piece of equipment at a time. Also, prevailing wages will need to be paid because of the Federal funding.

Background: Lockwood General Engineering has completed several projects for the City including the Downtown Pedestrian Corridor, Dinuba Sidewalks, and Garden Street Plaza. All projects were completed and the performance has been satisfactory on each project. Federal funds are being used in the project and there is a requirement that all bidders make a good faith effort to meet the City of Visalia's Disadvantaged Business Enterprise (DBE) goal of 8%. Staff reviewed and is satisfied with Lockwood's good faith efforts to obtain DBE participation on this project.

In July 2003, the City was awarded a Land and Water Conservation grant in the amount of \$41,000 that required a City match of the same amount. The first phase of this project constructed a trail on Tulare County property from the County Offices of Education to the intersection of Mineral King Avenue and West Main Street, approximately 2,200 feet. The West Main to Demaree phase will construct an additional 1,740 of trail. When both phases are complete, they will link to the existing trail between Demaree and Chinowith.

Currently the project has a balance of \$53,000 and additional funds are necessary to cover the cost of awarding the bid (\$1,733), contingencies (5%) and project inspection. Staff recommends that \$5,000 be transferred from the Waterway fund project1251-00000-720000-0-9756-2006 to cover Project 9629.

The Waterway Fund is for the acquisition, development and maintenance of riparian setbacks and derives funds from a combination of monthly storm sewer fees and developer impact fees. The fund receives approximately 20% of the monthly fee that is charged on the utility bill. The impact fee is paid by development on a per acre basis according to zoning and is the primary source for acquisition funding. Recently the Council took action to nearly triple the fee in order to keep pace with the increases in land values. Currently the fund has a deficit of \$377,000 and is projected to run a deficit for the next several years due to the number of recent development projects along the waterways that required acquisitions. Staff continues to monitor the fund and will make recommendations to fix the problem during the upcoming budget process.

Department Recommendation and Summary: It is recommended that \$5,305.00 be used from Asset Forfeiture Funds to add an additional dispatch console in the Communications Center of the Visalia Police Department.

At this time, the Communications Center is equipped with four fully functioning (phone and radio capable) consoles in addition to one partial console (that is not equipped with police and fire status monitors) that is currently set up in the Communications Supervisor's office for monitoring purposes. It is recommended that the phone system and radio system be removed from the supervisor's desk and placed in the Communications Center to be used as a much needed fifth console. The Computer Aided Dispatch System (CAD) and the recording equipment will remain in the supervisor's office for monitoring and administrative duties. To make the fifth dispatch console fully functional (phone and radio capable), the Police Department would need to purchase a PC, a video card, three additional monitors, a desk and the cost for the phone and radio technicians to move the existing equipment.

The desk to be purchased will be a regular office desk that is large enough to hold five monitors, a keyboard and an arbitrator. Due to the limited amount of space in the current Communications Center, a console (desk) that matches the other four work stations would be impossible to fit. The newly purchased desk and equipment will be placed in the center of the Communications Center where the fax machine and teletype terminal are currently located. The fax machine and teletype terminal will then be relocated to the east wall of the Communications Center.

The current location of the existing equipment in the Supervisor's office makes it possible for it to be used to answer phone calls only, due to there being no status monitors to show the locations of the police officers and fire personnel and it is only available during night time hours when the supervisor is off duty and not utilizing her office. There is a great need for the fifth

console during day time hours, but it cannot be used as such due to the supervisor's administrative duties.

As the City continues to grow at an enormous rate, so do the number of calls for service and the number of phone calls received by the Communications Center. In 2004, we averaged 8,450 calls for service per month; in 2005, we are averaging 8,855 calls for service per month. These numbers are just for the calls that are entered into the computer system. They do not include the number of calls that are referred to other agencies or departments or questions that are answered by Communications personnel. The actual number of calls received by the Communications Center is considerably higher.

Also, for the first time in a very long time, the Communications Unit is fully staffed and will have all Communications Operators fully trained by the end of November 2005. The addition of a fifth console will ensure that all Operators have a position to sit and work at during their shifts.

The cost of using the existing equipment, moving it and adding the additional pieces that will make it fully functional is considerably less than purchasing all new equipment. In addition, the existing equipment would then be used to its full potential.
