### Recommendation

That the Successor Agency Oversight Board does the following:

1) Approve the proposed Required Obligation Payment Schedule (ROPS) for the time period of July 1, 2018 to June 30, 2019 requesting \$628,247 in Real Property Tax Trust Fund (RPTTF) funding.

#### Background

Following dissolution of the Redevelopment Agency of the City of Visalia ("Agency"), the City elected to become the successor agency to the Agency by Resolution No. COV 12-01, dated January 17, 2012 (the "Successor Agency"). Pursuant to Health and Safety Code Section 34173(b), the Successor Agency is now a separate legal entity from the City. One of the responsibilities of the Successor Agency is to prepare a Recognized Obligation Payment Schedule ("ROPS"), which sets forth the nature, amount, and source(s) of payment of all "enforceable obligations" of the Agency (as defined by law) to be paid by the Successor Agency.

Previously, the ROPS was prepared for six-month fiscal periods. With the passage of SB 107, the ROPS has now converted to an annual report. The ROPS for the period July 1, 2018 to June 30, 2019 ("ROPS 18-19") is required to be submitted to the Department of Finance (DOF), the State Controller's Office and the County Auditor-Controller by February 1, 2018. Only payments required pursuant to the ROPS may be made by the Successor Agency.

#### **Discussion/Analysis**

The "enforceable obligations" listed in the ROPS may include the bonds; loans legally required to be repaid pursuant to a payment schedule with mandatory repayment terms; payments required by the federal government, preexisting obligations to the state or obligations imposed

by state law; judgments, settlements or binding arbitration decisions that bind the agency; legally binding and enforceable agreements or contracts; contracts or agreements necessary for the continued administration or operation of the agency, including agreements to purchase or rent office space, equipment and supplies; and amounts borrowed from or payments owing to the Low and Moderate Income Housing Fund of a redevelopment agency, which had been deferred as of June 29, 2011. However, the ROPS is to exclude pass-through payments to be made by the county after dissolution of the Agency and any agreements, contracts or arrangements between the City and the Agency; (1) any written agreements between the City and the Agency; or repaying indebtedness obligations to third parties; and (2) loan agreements entered into between the Agency.

Pursuant to Health and Safety Code Section 34177(o), the Successor Agency, is required to prepare an annual ROPS covering the period from July 1, 2018 through June 30, 2019 ("ROPS 18-19"). The ROPS is then to be submitted to the oversight board for approval. The approved ROPS is required to be submitted to the DOF, State Controller's Office and the County Auditor-Controller by February 1, 2018. The approved ROPS is also required to be posted on the City website. The deadline for the DOF to make its determination on the ROPS is April 13, 2018.

### Fiscal Impact

No City or Successor Agency funds are involved with the adoption of the ROPS. The ROPS simply lists existing enforceable obligations to be paid by the Successor Agency. Only payments listed on the approved ROPS and approved by DOF may be made by the Successor Agency.

#### Recommended Action

It is recommended that the Successor Agency adopt Resolution No. 2018-01 approving and adopting the Recognized Obligation Payment Schedule covering the period July 1, 2018 through June 30, 2019.
