Conditional Use Permit No. 2023-09: A request by Market Street Development LLC., to allow for a PACE senior care facility within an existing building measuring 24,975 square feet, on a parcel zoned C-MU (Commercial Mixed Use). The project is located on the north side of East Tulare Avenue, approximately 532 feet east of South Ben Maddox Way. (Address: N/A) (APN: 100-010-040).
