  - A new Arts Consortium special program called the Oval Gallery will be in the Oval Park building; includes gallery and printing shop in the Oval location. The Arts Consortium will provide the insurance for this program and pay the rent, collecting reimbursement for rent and utilities from the special program. Taking an agreement to Council to approve a new 2-Year lease with the option to renew up to 5 years. Helps the City with having a presence at that location.
  - The City is looking at piloting new business hours for customer service windows. There will be a campaign to promote and bring awareness to what's open and what's not. Proposed City hours will be Monday-Thursday, 7:30am-5:00pm and the Anthony Community Center open Monday-Thursday 7:30am-5:00pm and Fridays 7:30am-12:00pm. Animal Services hours extend to Tuesday-Friday, 8:00am-7:00pm and Saturdays, 8:00am-12:00pm (closed Mondays). Will potentially begin mid-February.

  - Kelli Kincaid ARPA fund for projects Alvin mentioned is already in place; with the proposed CIP's there are new expenditures, and we must be able to maintain the inventory what we already have and position ourselves for future development.
- Commissioner Hickey expressed her enjoyment of The Lofts' grand opening and the appreciation of the facility.
- Commissioner Monroy expressed his gratitude for the Parks & Recreation department staff. Looking forward to next year.
