BOOTH APPLICATION

1. **Applications:** All organizations interested in participating in any of the party for the planet events must submit to the City of Visalia a complete application and other documentation as required.
2. **Operating Hours:** Booths must be ready and open no later 30 minutes before the event start time.
3. **Check-In:** Organizations **MUST** check in at the Vendor Registration Booth to receive their booth space assignments. Event staff will direct them to their correct location and oversee setup.
4. **All vendors must provide their own tables/chairs/ and shade structures.**
5. **Vehicles:** For safety purposes no vehicles will be allowed on the ground except for food vendor trucks.
6. **Weather:** The Event will take place regardless of weather conditions.
7. **Electricity:** No electricity will be provided.
8. **Trash/Cleaning:** All vendors are responsible for keeping their booth space clean and free of trash and debris. At the close of the Event, vendors must leave their vacated booth space clean.
9. **Compliance with Laws:** All vendors are required to comply with all necessary and applicable local, state, and federal laws and ordinances. Food vendors must comply with all health laws, ordinances, and regulations of the State of California, County of Tulare, City of Visalia, pertaining to public health and sanitation.
10. **Indemnity:** All vendors are responsible for costs of all labor, materials, equipment, supplies, and any other items necessary for the performance of their participation in the Event. The Event will not be held liable for any debt, tax, or assessment accrued by any vendor in the operation of their booth and participation.
11. **Animals:** Animals are not permitted within the Event area, except registered service dogs and SPCA/City of Visalia Animal Services, or licensed entertainment.
12. **Security:** The Event is not responsible for the security of individual vendor booths. Vendors are responsible to secure their own booths, supplies, and equipment.
13. All booths must have an interactive activity that will empower our community to protect and serve our environment.
