## COUNCIL APPROVES 45-DAY MORATORIUM ON MEDICAL MARI-

**JUANA DISPENSARIES:** On a 5-0 vote, the City Council approved an urgency ordinance which imposes a 45-day moratorium on medical marijuana dispensaries and collective or cooperative cultivation and distribution enterprises. The moratorium provides time for staff and the City Attorney to analyze recent and currently pending court decisions which are central to a determination of whether these enterprises are operating legally or illegally under current state law and to determine appropriate revisions to the City's Medical Marijuana Business Ordinance, including the zoning provisions contained in that ordinance which was adopted in 2006. Council may extend the ordinance for an additional 10 months and 15 days and may further extend the ordinance for an additional year for a total of two years. Each extension requires a noticed public hearing prior to Council action and consideration of mandatory findings as it relates to State law.

### COUNCIL APPROVES HIRING CONSULTANT TO DESIGN ANIMAL

**CONTROL FACILITY:** Following two years of discussion,, the Visalia City Council voted 5-0 to hire a design consultant for the new Animal Control Facility. The new 17,250-square foot facility will be built on the same 4.6-acre spot along Highway 99. City staff will issue an immediate Request for Proposals, then begin the process of selecting and negotiating with a design consultant. The City has allocated \$521,880 for architectural, operational and construction plans. The new facility will feature about 100 dog kennels and 100 cat cages, allowing more room for animals. As many as 20,000 animals are expected to come through the operation this year. For the first six months of the year, Visalia Oaks SPCA Board President Tami Crawford said 90 percent of the cats and 50 percent of the dogs were euthanized. Crawford cited the lack of space at the existing shelter as at least, in part, responsible for the high numbers.

UPDATES ON CITY'S ROAD PROJECTS: Work is proceeding on the Houston Roundabout and Widening Project and the Santa Fe Overcrossing. The timeline for the next two weeks for Houston Roundabout is as follows: Week of Oct 19-Oct 23: Santa Fe Street, with connections to NE 1st and NE 2<sup>nd</sup>, to remain closed to through traffic. Douglas Avenue will remain closed from Santa Fe east for 400 feet (between Santa Fe and the old Soroptimist Park) for the installation of storm drain pipe in Douglas Avenue: Week of Oct 26-Oct 30: Santa Fe Street, with connections to NE 1<sup>st</sup> and NE 2<sup>nd</sup>, to remain closed to through traffic as storm drain is completed. NE 3<sup>rd</sup> will remain closed at Santa Fe and Houston Avenue for approximately one more week for reconstruction work on Houston Avenue and Santa Fe Street. Douglas Avenue could re-open to through traffic at some time during the week. Road closures and detours to remain in effect. Work in the intersection around the roundabout will continue. The timeline for the next two weeks for the Santa Fe Overcrossing is as follows: Week of Oct 19-Oct 23: Daytime ramp closures are planned for this week for Highway 198 near the Santa Fe Bridge. Westbound Central Visalia off-ramp (Court Street) and eastbound Central Visalia on-ramp (Court Street) are scheduled to be closed daily from 9 AM to 3 PM. Nighttime lane closures are planned for Highway 198 Monday night, 10/19/09, and Tuesday night, 10/20/09. The nighttime lane closures are scheduled from 8 pm to 6 am. Single lanes and Court Street on- and off-ramps will be closed as crews continue work over travel lanes and construct traffic barriers on the highway shoulders. A minimum of one highway lane will be open in both directions at all times during the nighttime closures. Week of Oct 26-Oct 30: Work will be done on Mineral King and Noble Avenues to prepare the roadway for paving. All work will be done during daylight hours.

### WORKPLAN FOR BROWNFIELDS CLEANUP AVAILABLE FOR PUB-

**LIC REVIEW:** Project documents for the Visalia Brownfields Cleanup project are available for public review online at www.envirostor.dtsc.ca.gov/public and at the Visalia branch of the Tulare County Library at 200 W. Oak Ave. The project is at the site of the City's proposed Civic Center on Burke Street, north of East Center Street. Cleanup work is necessary for the Site to be ready for the redevelopment of the Civic Center, and is expected to begin the week of Nov. 2. Work hours will be from 8 a.m. to 5 p.m. Monday through Friday and will take two weeks to complete. Work includes the excavation and removal of contaminated soil in areas where lead and arsenic exceed levels appropriate for residential uses.
