Receive Public Comment on Work Session and Closed Session Items -

1. Annual Visalia Rawhide Baseball Club Operation & Maintenance Report for 2009. **Receive public comment.**

Vince Elizondo, Parks and Recreation Director; Tom Siedler and Elizabeth Martin from the Rawhide Baseball team presented the year in review including recent renovations as well as future priorities. Recreation Park will receive the National Best Ball Park Renovation Award for 2009 later this month. Siedler reported attendance up 60% and estimated revenues for 2010 to the City will be \$132,250.

Council discussed methods for increasing revenue, conserving utilities, and naming rights.

Mr. Stanton presented his opposition to the taking of the property by eminent domain and offered his objection that the offer presented is inadequate and below appraisal. Mr. Stanton presented a handout of information to the Council to support his opposition. The public hearing was closed at 10:15 p.m.

City Attorney, Alex Peltzer, gave his rebuttal to Mr. Stanton's arguments and advised Council of their role to determine what constitutes the most public good for the least private harm.
