COUNCIL CONSIDERS LOCAL STIMULUS OPTIONS: The City Council heard from City staff and Chamber and Building Association representatives on options to stimulate the local economy—everything from impact fee waivers to a "buy Visalia" campaign. Council members urged continued discussions, including the legal ramifications of waiving existing impact fees in the city, and to bring recommendations to the City's 15-member Citizens Advisory Committee. The committee is expected to provide Council feedback on the stimulus plan at the April 5 Council meeting following a joint meeting with the Visalia Planning Commission . All Council members expressed support of streamlining the building permit process by putting them on-line and providing an on-line tracking of the permit processing. Concerns were raised by three Council members about the Chamber's recommendation to waive impact fees for residential, commercial and industrial projects initiated during the next 12 months. Mayor Bob Link wants to create a builder-friendly atmosphere to stimulate new jobs, but opposed the Chamber's idea of providing gift cards. Vice Mayor Amy Shuklian and Council Member Steve Nelsen also expressed reservations about the Chamber's proposal of fee suspensions, while Council Members Mike Lane and Warren Gubler expressed support of the proposal.

CONVENTION AND VISITORS BUREAU BRINGS BIG PROFITS WITH

SMALL INVESTMENT FROM CITY: The City Council learned about the \$1.5 million in business in 2009-10 brought into the City by the Visalia Convention and Visitors Bureau—almost five times the \$239,000 investment in the Bureau approved last year. The Great Western Fan Festival, a nationally known gospel-music event is coming to the Visalia Convention Center April 29-May 1, bringing with it 3,000 fans and generating about \$800,000 to the local economy. Convention participants in Visalia spend, on average, \$236 per day. In addition to bringing the "Fanfest" to Visalia, the bureau also was instrumental in getting the Amgen Tour of California professional cycling race to select Visalia as a Stage Start city not once, but twice. Amgen returns this year, with the Stage 5 Start on Thursday, May 20, on Main Street in downtown Visalia. This year's stage will go through Exeter, Lindsay and Porterville and, once again, showcase the City as a tourism designation.

CSET TO HOLD WORKSHOPS FOR THOSE FACING FORECLOSURE:

A new resource is available to Tulare County homeowners to address common questions relating to mortgages and foreclosures. The information from this workshop will help families understand the foreclosure process, what its implications are, and ways to avoid the issue all together. The first workshop will be held at 9 a.m. Saturday, March 20th at 312 NW 3rd Avenue in Visalia. "This new workshop series is aimed at homeowners who prefer to prevent foreclosure actions, or for those who are in the very early stages of foreclosure", said Lily Rivera-Graves, Director of Energy and Housing for CSET. During the 2-hour workshop, attendees will receive information about common lending terms and the best ways to communicate with lenders. Presenters will explain what happens to loans that become delinquent and will explain the timeline for the foreclosure process. Also included will be mortgage solution options including refinancing, possible loan modifications and repayment plans. To receive the full benefit from the workshop, residents should bring in a household budget. CSET staff can make recommendations

PARK UPDATE: The Visalia Parks and Recreation Department continues to upgrade park playgrounds throughout Visalia in 2010. The most recent renovations included the installation of new tot lot equipment at Blain Park (attached photos) located on South Court and Parkview in south Visalia. The new playground equipment was opened to the public on February 19. The City has spent over \$500,000 in playground renovations over the past six-months in Houk, Fairview, Jefferson, Summers, Whitendale, Village, and Pinkham Parks. Funding comes from a State grant awarded to the City several years ago. Outdated wooden equipment has been replaced with new ADA accessible equipment that will provide enjoyment for younger children through a variety of new and safe playground toys. PUBLIC WORKS PROJECT UPDATES

CENTER AVENUE: The work consists of installing new landscape curbs along the south side of Center Avenue, between Bridge and Conyer Streets. There will also be irrigation mains installed along this area, to serve the planter islands. Generally, work will commence on the east end of the project, at Bridge street, and proceed west in 2 block construction segments. The south travel lane (westbound) and adjacent parking will be impacted with this project. The City of Visalia project manager is Rebecca Keenan.

Timeline for the next two weeks:

Week of March 14 – March 20: Pavement will be placed in the trenches located between Bridge and Court Streets. This work will take approximately 1 day, depending on the weather. Later in the week, the Contractor will set up forms and pour curbs in the segment between Locust and Floral. There may be some concrete and pavement trucks in the area related to this work.

Week of March 21 - March 27: Work will continue west along Center Avenue. The areas to be impacted by work this week will be between Floral Street and Willis Street, in two-block increments.

HOUSTON ROUNDABOUT AND WIDENING: Crawford Construction is the General Contractor hired by the City of Visalia to do the work on the Houston Avenue project. The resident engineer is Adam Ennis with the City of Visalia. The project manager for the City of Visalia is Michael Carr. **Timeline for the next two weeks:**

Week of March 15 to March 19: Houston Avenue will be paved between Burke and Ben Maddox on Monday. Traffic will be shifted as needed to the north or south sidef of Houston Avenue. Reconstruction and pave-out of the west side of the Houston/Ben Maddox intersection is scheduled for Tuesday and Wednesday with traffic moved to the single inside lane for southbound Ben Maddox traffic. The signal will be set to the flashing red, 4-way stop mode during construction hours. The connections to the round-about from NE 3rd and Santa Fe Street will be reopened when striping and signage are completed. Traffic controls and posted Construction Zone speeds are to remain in effect on Houston Avenue until striping is complete and while traffic signal loops are installed.

Week of March 22 to March 26: Southern California Edison (SCE) should be installing street lights. Signing, striping and signal loops should be completed, and all streets coming into the roundabout will be opened to traffic by the end of the week. Southern Work to install cobblestones within the median on Ben Maddox from Sweet to Buena Vista should occur with the left-hand northbound lane closed.

SANTA FE OVERCROSSING: Agee Construction is the General Contractor hired by the City of Visalia to do the work on the Santa Fe Overcrossing. The resident engineer is David Vallejos with Mendoza and Associates. The project manager for the City of Visalia is Fred Lampe. **Timeline for the next two weeks:**

Week of March 15 to March 19: Work on decorative concrete features, fencing and architectural trim will continue. Highway 198 ramp closures are scheduled from 9 am to 3 pm, Monday through Friday, for the eastbound Court Street onramp and the westbound Court Street offramp. All work will be done in the daylight hours.

Week of March 22 to March 26: Cleaning exposed concrete along with installation of fencing and architectural features are scheduled for this week. Highway 198 ramp closures are scheduled from 9 am to 3 pm, Monday through Friday, for the eastbound Court Street onramp and the westbound Court Street offramp. All work will be done during daylight hours.
