As delineated on the Federal Emergency Management Agency's Flood Insurance Rate Map (Map Number 06107C09\_\_\_\_E) for Community No. 060409, City of Visalia, Tulare County, California, effective June 16, 2009, the property shown on this map lies fully within Zone AE, which are Special Flood Hazard Areas subject to inundation by the 1% annual chance flood with Base Flood Elevations determined. The Base Flood Elevation lines, values and the calculated minimum finished floor elevations are shown on this map.

<u>Vertical Datum Note</u>: Base Flood Elevation values shown on this map are converted from the North American Vertical Datum of 1988 (NAVD 88) to the City of Visalia datum based on the National Geodetic Vertical Datum of 1929 (NGVD 29) using the conversion factor of 2.73 established in Federal Emergency Management Agency's Flood Insurance Study dated June 16, 2009. The conversion factor of 2.73 is subtracted from the NAVD 88 value to obtain the equivalent NGVD 29 value.

## Statement 3:

As delineated on the Federal Emergency Management Agency's Flood Insurance Rate Map (Map Number 06107C09\_\_\_\_E) for Community No. 060409, City of Visalia, Tulare County, California, effective June 16, 2009, the property shown on this map lies fully within a flood zone area designated Zone X (shaded), which are areas of 0.2-percent annual chance flooding, areas of 1-percent annual chance flooding where average depths are less than 1 foot, areas of 1-percent annual chance flooding where the contributing drainage area is less than 1 square mile, and areas protected from the 1-percent annual chance flood by levees.

### Statement 4:

As delineated on the Federal Emergency Management Agency's Flood Insurance Rate Map (Map Number 06107C09\_\_\_\_E) for Community No. 060409, City of Visalia, Tulare County, California, effective June 16, 2009, the property shown on this map lies partially within Zone AE, which are Special Flood Hazard Areas subject to inundation by the 1% annual chance flood with Base Flood Elevations determined and partially within Zone X (shaded), which are areas of 0.2-percent annual chance flooding. The 1% annual chance flood plain boundary, Base Flood Elevation lines and values and the calculated minimum finished floor elevations are shown for the portions of this map that lie within the Special Flood Hazard Area.

<u>Vertical Datum Note</u>: Base Flood Elevation values shown on this map are converted from the North American Vertical Datum of 1988 (NAVD 88) to the City of Visalia datum based on the National Geodetic Vertical Datum of 1929 (NGVD 29) using the conversion factor of 2.73 established in Federal Emergency Management Agency's Flood Insurance Study dated June 16, 2009. The conversion factor of 2.73 is subtracted from the NAVD 88 value to obtain the equivalent NGVD 29 value.

### Statement 5:

As delineated on the Federal Emergency Management Agency's Flood Insurance Rate Map (Map Number 06107C09\_\_\_\_E) for Community No. 060409, City of Visalia, Tulare County, California, effective June 16, 2009, the property shown on this map lies fully within a flood zone area designated Zone X (unshaded), which are areas outside of 0.2% annual chance flooding.

# **Building Restrictions**

A temporary storm drainage easement over Lots \_\_\_\_\_ through \_\_\_\_\_ is granted to the City of Visalia. The City's recording of the cancellation document for the above referenced DECLARATION OF TEMPORARY BUILDING RESTRICTIONS will also serve as the City's abandonment of the temporary storm drainage easement.

### Lot Restrictions (temporary turnaround)

A portion of Lot 76 is subject to temporary lot restrictions as set out in DECLARATION OF TEMPORARY LOT RESTRICTIONS, recorded \_\_\_\_\_\_, 2007, as File No. 2007-\_\_\_\_\_ and as referenced to on this map.

A portion of Lot 76 contains a hammerhead turnaround that provides a City standard means of temporarily turning around vehicles traveling on the adjoining public street. A temporary turnaround easement over this portion of Lot 76 is granted to the City of Visalia. The City's recording of the cancellation document for the above referenced DECLARATION OF TEMPORARY LOT RESTRICTIONS will also serve as the City's abandonment of the temporary turnaround easement.
