**Details: On 01/30/11 @ approximately 0036 hours, Visalia Police Officers responded to a report of shots being fired on the 1400 block of N. Liberty. When Officers arrived on scene, they located an adult Asian male with a gunshot wound to the leg and a juvenile Asian male that had gunshot wounds to his back and right arm. Both victims stated they were walking in the area of Liberty and Sweet when they were shot by unknown subjects. Both subjects were transported by ambulance to Kaweah Delta Medical Center for treatment of non life threatening injuries.**
